The purpose of this memo is to notify you of the upcoming Advanced Compliance Workshop Series for the California Tax Credit Allocation Committee's (CTCAC) Compliance Monitoring program. In 2023, CTCAC will host both in-person Advanced Compliance Workshops and Virtual Advanced Compliance Workshops.
