IN-BOX

A Synopsis of Current Events in Public Finance

GFOA: FINANCIAL DISTRESS AND FISCAL FIRST AID RESOURCE

The Government Finance Officers Association (GFOA) has developed an online resource to help public officials cope with budgetary difficulties and ultimately improve the financial health of their governments. This online resource contains a process for fiscal recovery, a catalog of fiscal first aid techniques, and a list of other resources for recovery from financial distress.

According to this online resource there is a twelve-step process for dealing with financial distress. These steps are categorized into three major stages, which are described below:

THE BRIDGE STAGE. The first stage of the recovery process starts with establishing a jurisdiction's financial condition and communicating it to the jurisdictions' leadership to create a shared understanding of the situation and a common basis for taking action. Since no single public official can carry out recovery efforts alone this stage has been named the "bridge stage" because it emphasizes creating a leadership team to guide the recovery process. During this stage the jurisdiction's financial condition needs to be stabilized. The development of a short-term recovery plan marks the end of the bridge stage.

THE REFORM STAGE. The goal of the second stage, the reform stage, is to enact the recovery plan developed during the bridge stage and continue to develop and implement long-term recovery strategies. In this stage, the municipality should start developing a long-term financial plan to guide a consistent, multi-year approach to improving financial health and to institutionalize good financial management practices.

THE TRANSFORMATION STAGE. The goal of the third stage, the transformation stage, is to achieve financial resiliency by institutionalizing long-term financial planning and becoming more adaptable to changing conditions, more resistant to financial distress, and better equipped to regenerate in the face of setbacks. In this stage, the long-term strategies that were initialized in the reform stage are coming to fruition. Many of these strategies, like developing financial policies and more effective long-term forecasting, contribute directly to making an organization more financially resilient. In the transformation stage, the recovery leadership continues to develop and implement additional strategies to improve financial management and decision making.

The GFOA online resource provides comprehensive information on these three stages and the 12 steps associated with them. Other highlights of this resource include a catalog of short-term retrenchment tactics, a diagnostic model that can be used to pinpoint problem areas, and a guide to the most important long-term

strategies for a municipality's financial health. GFOA's *Recovery from Financial Distress and Fiscal First Aid* resource is available online, www.gfoa.org/financialrecovery.

MSRB: PAY TO PLAY RULES FOR ADVISORS

The MSRB plans to publish new Payto-Play rules for advisors by the end of December 2010. The MSRB held meetings in Alexandria, Virginia, in December to begin the discussion of how to develop a fiduciary duty rule and associated interpretations for municipal advisors. Specifically, the MSRB is looking at new guidelines for municipal advisors pertaining to restrictions from engaging in or soliciting business from municipal entities when an advisor has made certain political contributions to municipal officials responsible for awarding that business.

This rule would elaborate on a provision in the Dodd-Frank Wall Street Reform and Consumer Protection Act that imposes a fiduciary duty on municipal advisors but leaves development of the rule to the MSRB. The MSRB expects to publish for comment a principles-based fiduciary-duty rule and interpretive guidance in early 2011.

During these meetings, the MSRB also approved an SEC filing that would require a municipal advisor to notify the MSRB when the advisor ceases to engage in municipal advisory activities, whether voluntarily or due to sanctions by the SEC.

MUNICIPAL SECURITIES RULEMAKING BOARD OUTREACH SEMINAR

The Municipal Securities Rulemaking Board (MSRB) will host an outreach seminar in Los Angeles for municipal market professionals on Tuesday, January 25, 2011, at the Omni Los Angeles Hotel. Seminar sessions will address MSRB's expanded mission resulting from the Dodd-Frank Wall Street Reform and Consumer Protection Act, Electronic Municipal Market Access (EMMA) website and municipal disclosure, and municipal advisor and dealer rulemaking.

The seminar will be held in conjunction with MSRB's Board of Directors meeting and is open to all members of the municipal community including municipalities, investors, municipal advisors and registered broker-dealers. There is no cost to attend the event but space is limited and pre-registration is required. DATA-CORNER

A MONTHLY UPDATE FROM CDIAC'S DATA COLLECTION AND ANALYSIS UNIT

WHAT IS "CUT-OFF"?

Pursuant to Government Code Section 8855(h)(3) the California Debt and Investment Advisory Commission (CDIAC) must "collect, maintain, and provide comprehensive information on all state and all local debt authorization and issuance, and serve as a statistical clearinghouse for all state and local debt issues. CDIAC is also required to publish a monthly newsletter that contains a summary of the previous month's submissions."

To satisfy these statutory requirements, the Data Collection and Analysis Unit (Data Unit) maintains a database compiled of information submitted to CDIAC on the Reports of Proposed Debt Issuance (RPDIs), Reports of Final Sale (RFSs) and Yearly Fiscal Status Reports (YFSR) for Marks-Roos and Mello-Roos financings. Reports are run monthly from information entered into the database and are posted monthly on the CDIAC website and compiled into the *Calendar of Issues* for inclusion in *Debt Line*, CDIAC's monthly newsletter.²

To run the monthly reports, there is an established "cut-off" deadline of 12:00 pm, on the 15th of each month to receive data and include that data in the current month's reports.³ Information received after noon on the 15th will be reflected on the following month's reports (e.g., if received by noon on

December 15th, data will be recorded in the December Calendar of Issues, if received after noon, data will be in the January Calendar of Issues). During "cut-off," staff stops entering data into the Debt Issuance Database including uploading internet submissions and RPDIs and RFSs received by email, fax or regular mail. All reports received prior to cut-off are entered into the database, audited and verified for inclusion in the appropriate monthly report. All information received after "cut-off" will be entered into the database once the "cut-off" verification process is completed and will be reflected in the next month's reports.

During "cut-off" submitters may experience a longer than normal wait time to receive acknowledgement letters for RPDIs and RFSs. Depending on staffing levels and the volume of reports received each month, the cut-off process normally takes between one to three business days. Staff will begin to acknowledge receipt of RPDIs after the *Debt Line Calendar* has been finalized. RFSs are not accepted or acknowledged until all other monthly reports have been finalized.

"Cut-off" is a very important and busy time of month for the Data Unit staff. It signals the beginning of many of our other processes, including invoicing for the payment of debt issuance fees and the verification that all reported proposed sales that were slated to occur by the 15th of the month but have not occurred, are still scheduled to occur.

SELECTED REPORTING REQUIREMENTS

Under existing law (California Government Code Section 8855(k)), "The issuer of any proposed new debt issue of State or local government (or public benefit corporation incorporated for the purpose of acquiring student loans) shall, not later than 30 days prior to the sale of any debt issue at public or private sale, give written notice of the proposed sale to the Commission, by mail, postage prepaid."

Under California Government Code Section 8855(I), "The issuer of any new debt issue of State or local government (or public benefit corporation for the purpose of acquiring student loans) shall, not later than 45 days after the signing of the bond purchase contract in a negotiated or private financing, or after the acceptance of a bid in a competitive offering, submit a report of final sale to the commission by mail, postage prepaid, or by any other method approved by the commission. A copy of the official statement for the issue shall accompany the report of final sale. The Commission may require information to be submitted in the report of final sale that is considered appropriate."

Under California Government Code Section 53583(c)(2)(B) if a "local agency determines to sell the (refunding) bonds at private sale or on a negotiated sale basis, the local agency shall send a written statement, within two weeks after the bonds are sold, to the California Debt and Investment Advisory Commission explaining the reasons why the local agency determined to sell the bonds at private sale or on a negotiated sale basis instead of at public sale."
