2011 MUNICIPAL BOND ISSUANCE NUMBERS

In 2011, nationwide municipal bond issuance activity totaled \$355.5 billion, down from a record high of \$498.4 billion in 2010.¹ This decrease may be attributable to the fiscal austerity measures employed by public agencies and the end of the Build America Bonds program in 2010.

Issuance activity in California also declined in 2011 with public agencies issuing approximately \$57.5 billion in total obligations—a decrease of 36.4 percent from the \$90.5 billion sold in 2010. State-level debt issuance dropped 37.1 percent from \$38.3 billion in 2010 to \$24.1 billion in 2011 and local issuance dropped 35.9 percent from \$52.2 billion in 2010 to \$33.5 billion in 2011 (Figure 1).² The lower state-level total reflects the State of California's decision to limit bond issuance activity as part of the FY 2010-11 and FY 2011-12 State Budgets. Lean budgets, the dismantling of redevelopment agencies, and municipal market conditions were all factors impacting the types and volumes of debt issued in 2011.

While total issuance decreased by more than a third in 2011, the percentage of total debt issued as refunding debt grew substantially from 19.1 percent in 2010 to 32.7 percent in 2011.² (Figure 2) In fact, total refunding volume in 2011 exceeded the total in 2010 by 8.7 percent.

Capital improvements and interim financing continued to be the top two purposes

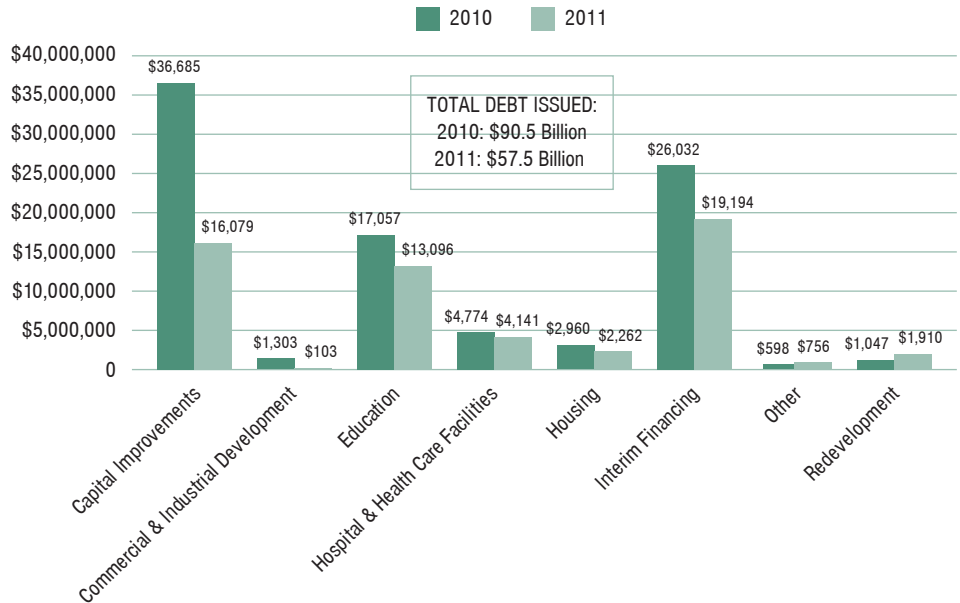

of debt issued in 2011. (Figure 3) Although bonds sold for redevelopment represent a very small portion of the overall debt issued, redevelopment agencies issued more than 82 percent more debt in 2011 than in 2010. All of the 2011 redevelopment debt was issued in the first six months of 2011, just prior to the Governor signing the legislation that halted redevelopment debt issuance and dismantled redevelopment in California.³

The fiscal stress experienced by state and local governments, and the reluctance of agencies to take on new debt in the midst of intense budgetary uncertainty kept nationwide municipal debt issuance on a downward trend in 2011 to the lowest volume since 2001. California municipal issuance dropped off by an even greater percentage than the nation from 2010 to 2011 reflecting the severity of the recession in California, slow pace of recovery, and lag between economic improvement

and state and local revenue growth. Perhaps the most noteworthy statistics from 2011 were the continued strong rate of refunding issues in the midst of the overall low volume and the rush by redevelopment agencies to issue new tax increment debt prior to their elimination.

SELECTED REPORTING REQUIREMENTS

Under existing law (California Government Code Section 8855(i)), "The issuer of any proposed new debt issue of State or local government (or public benefit corporation incorporated for the purpose of acquiring student loans) shall, not later than 30 days prior to the sale of any debt issue at public or private sale, give written notice of the proposed sale to the Commission, by mail, postage prepaid."

Under California Government Code Section 8855(j), "The issuer of any new debt issue of State or local government (or public benefit corporation for the purpose of acquiring student loans) shall, not later than 45 days after the signing of the bond purchase contract in a negotiated or private financing, or after the acceptance of a bid in a competitive offering, submit a report of final sale to the commission by mail, postage prepaid, or by any other method approved by the commission. A copy of the official statement for the issue shall accompany the report of final sale. The Commission may require information to be submitted in the report of final sale that is considered appropriate."

Under California Government Code Section 53583(c)(2)(B) if a "local agency determines to sell the (refunding) bonds at private sale or on a negotiated sale basis, the local agency shall send a written statement, within two weeks after the bonds are sold, to the California Debt and Investment Advisory Commission explaining the reasons why the local agency determined to sell the bonds at private sale or on a negotiated sale basis instead of at public sale."
