Agenda Item 3 – Executive Director's Report (INFORMATION ITEM)

Executive Director Christina Elliott presented to the Board a verbal report on the budget, outreach efforts, and regulations. Ms. Elliott stated the Board has spent about \$500,000 of the \$850,000 it received in a General Fund loan for Fiscal Year 2016/2017; staff has reduced outreach to focus on program design and has begun the regular rulemaking process with a hearing scheduled for July 18, 2017 at 10 a.m.

Agenda Item 4 – Request for Proposals for Program Administrator and Investment Manager ("Program Manager") Services Update (INFORMATION ITEM)

Executive Director Christina Elliott presented to the Board a verbal report on Request for Proposals (RFP) for Program Manager. Ms. Elliott stated that the proposals received were deemed nonresponsive by the evaluation committee. Ms. Elliott also stated that staff, with the help of the Board's 529A program consultant, 529A investment consultant, and legal counsel, has revised the RFP and intends to reissue it mid-June.

Chairperson Brown asked for public comment. Lori Cochrane made public comment, inquiring about the reason proposals were deemed nonresponsive. Ms. Elliott stated the proposals either did not meet the scope of work requirements laid out in the RFP or failed to abide by the non-negotiable procurement rules set by the Department of General Services.

Agenda Item 5 – 529A Program Consultant Update: Andrea Feirstein (AKF Consulting LLC, dba AKF Consulting Group) (INFORMATION ITEM)

The Board's 529A program consultant, Andrea Feirstein of AKF Consulting LLC, gave a verbal report on the latest update on 529A plans across the nation. Ms. Feirstein reported that Massachusetts launched its ABLE Program which is managed by Fidelity. New York, Washington D.C., and Georgia will also launch their programs soon.
