SUMMARY OF THE REQUEST:

At the April 24, 2014 Authority meeting, the Authority approved nine final allocations for the IMHWGP totaling \$3,974,289.42 in personnel funding for the first funding round. At the December 4, 2014 Authority meeting, the Authority approved one final allocation totaling \$24,653.56 in personnel funding for the second funding round.

On December 3, 2015, the Authority approved extensions to resolution expiration dates for personnel funding for a number of counties due to the Legislature appropriating additional funds for personnel costs.

The first year of personnel funding was appropriated in the FY 2013-14 Budget Act and required to be disbursed by June 30, 2016. The second year of personnel funding was appropriated in the FY 2014-15 Budget Act and is required to be disbursed by June 30, 2017. The third year of personnel funding was appropriated in the FY 2015-16 Budget Act and is required to be disbursed by June 30, 2018.

In the 2016-17 FY Budget Act signed by the Governor, the Legislature appropriated \$4 million for a fourth year of additional personal funding that is required to be disbursed by June 30, 2019.

If the Legislature continues to appropriate funds for personnel costs for additional fiscal years, the removal of the resolution expiration dates and delegation to the Executive Director will allow Authority staff to disburse the additional personnel funds without requiring further action by the Authority at a meeting each year.

RECOMMENDATION:

Staff recommends the Authority approve amendments to the resolutions, as identified in Table 1, removing all resolution expiration dates and authorizing the Executive Director to continue to disburse mobile crisis support team personnel funds as may be established in future Budget Acts. All other conditions in the resolutions shall remain the same and in full effect.

The proceeds of the grant will be used by the County of Contra Costa as follows:

The County of Contra Costa (the "County") will expand an existing mobile crisis program as well as establish new Mobile Crisis Support Teams ("MCST"). The County will increase access and capacity by adding three (3) new vehicles, hire three (3) full-time mental health clinicians, and hire one (1) part-time community support worker. Two (2) vehicles will be operated by the County to serve the adult system of care. The County will also collaborate with its designated service provider, Seneca Family of Agencies, to operate one (1) vehicle to serve the children's system of care. The County expects the MCST services will primarily occur within family's homes, but other locations include foster homes, group homes, schools, and other community settings. Grant funds will be used to purchase and equip vehicles, for three (3) months of program startup costs, and for personnel to staff the vehicles.

PROJECT DESCRIPTION

The proceeds of the grant will be used by the County of Riverside as follows:

Crisis Residential Treatment Program

The County of Riverside (the "County") will establish a Crisis Residential Treatment Program, which will increase capacity by adding 16 new beds. The program will be the County's first new peer-to-peer enhanced crisis residential program intended to serve the Western Region. The program will provide a home-like service environment with 24/7 access for diversion alternatives to non-emergency department based services and involuntary inpatient treatment. This program will provide the ability to continue the robust peer recovery approach introduced by the proposed co-located peer crisis stabilization program. The funds will be used to construct, furnish and equip a building, and finance information technology.

Crisis Stabilization Treatment Program

The County will establish a Crisis Stabilization Treatment Program that will provide urgent care/crisis support for up to 23 hours per encounter. The program will operate 7 days a week, 24 hours a day. The program will provide voluntary peer-to-peer enriched engagement and support in addition to clinical and psychiatric assessment, crisis intervention, and supportive therapy to individuals who are experiencing a mental health crisis. The service environment will be designed to be homelike. The building is strategically located next to its existing crisis stabilization program. The funds will be used to construct, furnish and equip a building, and finance information technology.

Mobile Crisis Support Team Program

The County will establish a mobile crisis support team in each of its three regional service areas to increase access and respond to areas with the highest rates of law enforcement initiated involuntary holds. The teams will respond to requests from local law enforcement to assess and intervene with persons experiencing a mental health crisis. A team will consist of two members, a behavioral health specialist or clinical therapist and a mental health peer specialist. The funds will be used to purchase three vehicles, equip them and to fund the salaries of 13 staff members.

A RESOLUTION OF THE CALIFORNIA HEALTH FACILITIES FINANCING AUTHORITY APPROVING EXECUTION AND DELIVERY OF GRANT FUNDING UNDER THE INVESTMENT IN MENTAL HEALTH WELLNESS GRANT PROGRAM TO THE COUNTY OF SAN JOAQUIN

WHEREAS, The California Health Facilities Financing Authority (the "Authority"), a public instrumentality of the State of California, is authorized by the Investment in Mental Health Wellness Act of 2013 (Welfare and Institutions Code Section 5848.5, "Act") and implementing regulations (California Code of Regulations Title 4, Division 10, Chapter 5 (commencing with Section 7113)) to award grants for capital funding and personnel funding to finance eligible projects; and

WHEREAS, Authority staff reviewed the application submitted by County of San Joaquin ("Grantee") against the eligibility requirements of the Act and implementing regulations and, pursuant to the Act and implementing regulations, recommends approval of a grant in an amount not to exceed \$2,508,704.12 for the eligible project (the "Project"), which consists of no more than \$1,836,783.50 for crisis stabilization capital costs, \$206,400.00 for mobile crisis capital costs, and \$465,520.62 for mobile crisis personnel costs; and

<u>WHEREAS</u>, the Legislature has and may continue to appropriate funds for mobile crisis support team personnel costs in future fiscal years;

NOW THEREFORE BE IT RESOLVED by the California Health Facilities Financing Authority, as follows:

<u>Section 1.</u> The Authority hereby approves a grant in a total amount not to exceed \$2,508,704.12 to complete the Project as described in the Grantee's application and as more particularly described in Exhibit A to this Resolution (Exhibit A is hereby incorporated by reference) within a <u>project grant</u> period that ends on <u>December 31, 2016</u>. December 31, 2016. Nevertheless, if the Legislature continues to appropriate funds for mobile crisis support team personnel costs in future fiscal years, the Executive Director is authorized to continue to disburse those funds as may be available under the State Budget Act for each fiscal year and the Executive Director may accordingly extend the grant period for purposes of mobile crisis support team personnel funding only.

<u>Section 4.</u> The Executive Director of the Authority is hereby authorized and directed to do any and all things and to execute and deliver any and all documents which the Executive Director deems necessary or advisable in order to effectuate the purposes of this Resolution and the transactions contemplated hereby.

<u>Section 5.</u> This Resolution expires December 31, 2015.

PROJECT DESCRIPTION

The proceeds of the grant will be used by the County of San Joaquin as follows:

Crisis Stabilization Program

The County of San Joaquin (the "County"), will add two voluntary crisis stabilization units, a four-bed adult unit and a four-bed children and youth unit. Current crisis stabilization capacity in the County will double. The new clinical areas and services offered will create a "sense of hopefulness" to the individuals experiencing a mental health crisis. Outdoor areas will provide for quiet space and relaxation and big windows will capture natural light to "increase the natural feeling of recovery." The funds will be used to construct the youth and adult crisis stabilization units, renovate a shared nursing unit, construct a separate entrance for the children and youth crisis stabilization, provide access to dedicated outdoor areas, furnish and equip the crisis stabilization units, and purchase information technology. The Crisis Stabilization program will be operational by July 1, 2015, following a six month construction process.

Mobile Crisis Support Team

The County will create three Mobile Crisis Support Teams with expanded hours of operation. The three Mobile Crisis Support Teams will be stationed in strategic locations and dispatched to provide services for three different targeted populations: children in group and foster care homes, consumers with a history of justice involvement, and individuals who have difficulty accessing planned health services. The funds will be used to purchase three vans, which will be customized with handicap access and captain's chairs for a relaxing environment. The Mobile Crisis Support Team program will be operational by September 1, 2014.

Nevertheless, if the Legislature continues to appropriate funds for mobile crisis support team personnel costs in future fiscal years, the Executive Director is authorized to continue to disburse those funds as may be available under the State Budget Act for each fiscal year and the Executive Director may accordingly extend the grant period.

<u>Section 4.</u> The Executive Director of the Authority is hereby authorized and directed to do any and all things and to execute and deliver any and all documents which the Executive Director deems necessary or advisable in order to effectuate the purposes of this Resolution and the transactions contemplated hereby.

PROJECT DESCRIPTION

The proceeds of the grant will be used by the County of San Joaquin as follows:

Mobile Crisis Support Teams

San Joaquin County is requesting a Grant in the amount of 0.5 full time equivalent to convert two part-time positions to one full-time positions, expanding hours of staff coverage for at least one of the three Mobile Crisis Support Teams ("Teams") approved for a Grant in the first funding round. The three Teams will have expanded hours of operation, service locations, and response capacity to fill critical gaps in the County's continuum of care. The Teams will be stationed in strategic locations and dispatched to provide crisis services and alternatives to involuntary hospitalizations and incarcerations for three different targeted populations: children in group and foster care homes, consumers with a history of criminal justice system involvement, and individuals who have difficulty accessing planned health services. The County projects that the Teams will be operational by April 2015.
