

NOTICE OF PUBLIC HEARING
CHFFA/SUTTER HEALTH

Notice is hereby given that on July 22, 2016, a public hearing as required by Section 147(f) of the Internal Revenue Code (the "Code") will be held by the California Health Facilities Financing Authority (the "Authority") with respect to the proposed issuance by the Authority of its revenue bonds in one or more series (the "Bonds"), in an amount not to exceed \$151,000,000. Proceeds of the Bonds will be used by Sutter Health (the "Corporation") to refund certain bonds previously issued to finance and refinance the costs of acquisition, construction, expansion and improvement of the health facilities owned by the Corporation or its affiliates, and operated by the affiliates of the Corporation and generally located at the addresses in California as follows:

- (i) Mills-Peninsula Health Services d/b/a Sutter Maternity and Surgery Center of Santa Cruz at 2900 Chanticleer Avenue, Santa Cruz;
- (ii) Sutter Valley Medical Foundation d/b/a Sutter North Medical Foundation at 480 Plumas Street and 550 B Street, Yuba City;
- (iii) Sutter Central Valley Hospitals d/b/a Memorial Medical Center at 1700 Coffee Road, Modesto;
- (iv) Sutter Valley Hospitals d/b/a Sutter Roseville Medical Center at One Medical Plaza Drive, Roseville;
- (v) Sutter Valley Hospitals d/b/a Sutter Medical Center at 2801 L Street and 2825 Capitol Avenue, each in Sacramento;
- (vi) Sutter Valley Hospitals d/b/a Sutter Auburn Faith Hospital at 11815 Education Street, Auburn;
- (vii) Sutter Valley Hospitals d/b/a Sutter Davis Hospital at 2000 Sutter Place, Davis; and
- (viii) Sutter Valley Medical Foundation d/b/a Sutter Medical Foundation at 2020 Sutter Place, Davis.

Each of the Corporation and its affiliates is a California nonprofit public benefit corporation and an organization described in Section 501(c)(3) of the Code. The hearing will commence at 10:00 a.m., or as soon thereafter as the matter can be heard, and will be held in Suite 590, 915 Capitol Mall, Sacramento, California. Interested persons wishing to express their views on the issuance of the Bonds or on the nature and location of the health facilities proposed to be financed or refinanced may attend the public hearing in person or by phone (888) 240-3210 (participation code 955669) or TDD (916) 654-9922 or, prior to the time of the hearing, submit written comments to Diane Stanton, Executive Director, California Health Facilities Financing Authority, 915 Capitol Mall, Suite 590, Sacramento, California 95814. The Authority may limit the time available for persons attending the public hearing to provide comments while assuring such persons a reasonable opportunity to be heard.
