The application deadline for 2015 second round low income housing tax credit applications was on Wednesday, July 1, 2015. The California Tax Credit Allocation Committee (TCAC) received a total of 87 nine percent (9%) applications and 4 four percent (4%) applications (requesting federal and state tax credits) in the second round of 2015. TCAC staff has provided a quick summary of the projects received.
