SUBJECT: 2007 and 2008 Cash In Lieu of Credits Applicant Projects

Pursuant to Section 10323(d)(1) of the California Tax Credit Allocation Committee (TCAC) Regulations implementing the American Recovery and Reinvestment Act of 2009, TCAC may award cash in lieu of tax credits to projects unable to secure an equity partner. On May 12, 2009, TCAC released its first application for cash in lieu of credit awards, limited to projects with a current 2007 or 2008 reservation of federal credits only.

A total of 31 applications have been submitted thus far. All of the project applicants have submitted documentation to demonstrate an unsuccessful good faith effort to obtain investment commitments for the tax credits. TCAC is making the list of projects available to the public, and equity investors in particular, in furtherance of efforts to promote private investment in affordable housing.

As shown attached, the projects encompass the full range of tax credit projects with respect to geographical region, housing type, and sponsorship. We encourage tax credit investors to review the attached information and contact sponsors for additional information. Please also contact TCAC if you intend to pursue a listed project as an investment opportunity.
