## **MINUTES**

Ms. Jacqueline Wong-Hernandez moved to approve the minutes for the August 15, 2018 meeting. Upon a second by Mr. Dowell the motion passed 2-0 with the following votes: Mr. Dowell: yes; Ms. Wong-Hernandez: yes.

#### PMIB DESIGNATION

Ms. Tracey Paine of the State Treasurer's Office presented a Portfolio Summary Report as of August 31, 2018. On that day, the portfolio stood at \$86.197 billion. The effective yield was 2.036%, the quarter-to-date yield was 1.971% and the year-to-date yield was 1.971%. The average life of the portfolio was 191 days. AB55 Loans approved were \$791 million, with a disbursed amount of \$412 million. The Local Agency Investment Fund had \$20.403 billion total deposits, with 2,405 total participants.

Ms. Paine presented Designation No. 1831. In accordance with Treasurer's Office policy, the recommended deposit in demand bank accounts as Compensating Balance of Services is \$282,400,000.

Ms. Wong-Hernandez moved to approve Designation No. 1831. Upon a second by Mr. Bill Dowell the motion passed 2-0 with the following votes: Mr. Dowell: yes; Ms. Wong-Hernandez: yes.

#### AUTHORIZATION FOR GENERAL FUND INTERNAL BORROWING

Ms. Paine presented this document, which authorizes the General Fund to borrow from internal sources to meet its cash needs during periods of shortfall. The Authorization for General Fund Internal Borrowing is for the period October 1, 2018 through December 31, 2018, in the amount of up to \$45.492 billion. Ms. Wong-Hernandez moved to approve the Authorization for General Fund Internal Borrowing. Upon a second by Mr. Dowell the motion passed 2-0 with the following votes: Mr. Dowell: yes; Ms. Wong-Hernandez: yes.

## DECLARATION OF SURPLUS MONEY/REDUCTION OF SURPLUS MONEY

Ms. Paine presented the changes in the Surplus Money Investment Fund for the period August 1, 2018 through August 31, 2018. Declaration of Surplus Money was in the amount of \$11.036 billion. A reduction in Surplus Money was in the amount of \$12.265 billion. An attachment to the Declaration letter showed the breakdown.
