Attachment #2 – Proposed 2017 timeline for California Secure Choice Retirement Savings Investment Board

October - December 2016

- Begin discussions with Employment Development Department (EDD) on design and implementation of operational model
- Begin recruitment of Executive Director in November (incumbent cannot begin until January 1, 2017)
- Continue pursuit of ‘No action’ letter from Securities and Exchange Commission (SEC)
- Develop advisory groups for business stakeholders and asset building/financial capability advocates

January - March 2017

- Recruit and hire Executive Director, Manager, and Analyst to develop and implement Secure Choice
- Develop Request For Proposals (RFP) for regulations development consultant, recordkeeping services consultation, and investment management
- Continue pursuit of “No action” letter from SEC

April - June 2017

- Issue RFPs for regulations development consultant, recordkeeping services consultation, and investment management
- Review proposals received for regulations development consultant, recordkeeping services consultation, and investment management

July - September 2017

- Award contracts for regulations development consultant, recordkeeping services consultation, and investment management
- Begin regulatory processes to develop regulations necessary for operation of the Program

October - December 2017

- Begin development of Secure Choice investment policies that define the Program’s investment objectives
- Begin design and development of employee information packet to be provided to employees eligible for Secure Choice
