The Office of Administrative Law approved and filed these adopted regulations with the Secretary of State on February 29, 2012.

As of the date of this letter, all new loans submitted for consideration for enrollment in the Program must meet the regulatory requirements as prescribed in the California Capital Access Program Regulations.
