The emergency regulations amended five sections pertaining to the Capital Access Program for Small Businesses under title 4, division 11, article 7 of the California Code of Regulations. As a result of federal funding allocations to the program in 2011, CPCFA is developing a collateral support program that will be organized slightly differently than the current Capital Access Program. Clarification of the existing regulations is necessary to operate both programs harmoniously and ensure the functionality of the two programs.
