Information that cannot be anonymized and aggregated will not be released to the public.

In addition to the anonymized and aggregated release of information contemplated above, CAEATFA may contact Borrowers or may release individual borrower names, addresses, email addresses and phone numbers to Investor Owned Utilities and/or your electric of gas utility company, the CPUC, or individuals acting on their behalf, to contact borrowers. The purpose of the release and contact information will be limited to inviting borrowers to participate in surveys or to arrange visits to borrowers' homes to evaluate various aspects of the program.
