REQUEST

Staff requests approval of the Fiscal Year (FY) 2019/20 Interagency Agreement ("IA") with the State Treasurer's Office ("STO") to provide executive and administrative support to the Authority in the amount of \$367,024.00 during the term July 1, 2019 through June 30, 2020.

SUMMARY

Background. Through annual IAs, the STO provides legislative, budgeting, personnel, accounting, information systems, and other administrative support services for the Boards, Commissions, and Authorities ("BCAs") chaired by the State Treasurer. The total cost is allocated among the BCAs based on each agency's personnel-years. Since FY 2015/16, the increased overall support cost is primarily attributable to the expansion and modernization of the STO information technology division, to facilitate its mission of delivering more efficient and effective technology support and procurement services to all STO divisions and BCAs. The IA for FY 2015/16 included a greater cost due to the information technology division's initial purchase of new equipment; these initial upgrade purchases were completed and subsequent executive and administrative support IA costs for have not increased as substantially. Expansion of the California Hub for Energy Efficiency Financing ("CHEEF") programs and establishment of additional positions in FY 2017/18 slightly increased the cost allocation for that year. Prior contract amounts for the FY 2010/11 through FY 2017/18, as well as the current contemplated agreement amount, are listed below. The decrease in cost for this current fiscal year (FY 2019/20) is due to the expiration of the Data and Government Transparency Unit (DAGT) positions in the Information Technology (IT) Department.

WHEREAS, the California Alternative Energy And Advanced Transportation Financing Authority (the "Authority"), a public instrumentality of the State of California, is authorized and empowered by the provisions of the California Alternative Energy And Advanced Transportation Financing Authority Act (Division 16 (commencing with Section 26000) of the California Public Resources Code) (the "Act"); and

WHEREAS, the Authority wishes to enter into an Interagency Agreement with the State Treasurer's Office for the provision of executive and support services including, but not limited to, accounting, budgeting, legal services, information technology services, information security office, personnel, and business services; and

WHEREAS, the State Treasurer's Office has the ability and expertise to provide executive and support services for the Authority.

NOW, THEREFORE, BE IT RESOLVED by the Authority, as follows:

<u>Section 1</u>. The Authority hereby authorizes the execution of an Interagency Agreement with the State Treasurer's Office for the provision of Executive and Support Services, in an amount not to exceed \$367,024.00.

Section 2. The term of the contract shall begin on July 1, 2019 and shall continue through June 30, 2020.

<u>Section 3.</u> The Executive Director shall execute and submit the Interagency Agreement to the Department of General Services for approval.

Section 4. This resolution shall take effect immediately upon its approval.

EXHIBIT B BUDGET DETAIL AND PAYMENT PROVISIONS

1. Invoicing

- A. The California Alternative Energy and Advanced Transportation Financing Authority (CAEATFA) agrees to compensate the State Treasurer's Office (STO) a lump sum payment in the amount of \$367,024.00 due no later than 30 days after contract approval.

2. Budget Contingency Clause

- A. It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under this Agreement does not appropriate sufficient funds for the program, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to Contractor or to furnish any other considerations under this Agreement and Contractor shall not be obligated to perform any provisions of this Agreement.
- B. If funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this program, the State shall have the option to either cancel this Agreement with no liability occurring to the State, or offer an agreement amendment to Contractor to reflect the reduced amount.

3. Payment

- A. Costs for this Agreement shall be computed in accordance with State Administrative Manual Sections 8752 and 8752.1.
- B. Nothing herein contained shall preclude advance payments pursuant to Article 1, Chapter 3, Part 1, Division 3, Title 2 of the Government Code of the State of California.
