**RE: Sugar Valley Energy, LLC Appeal to Continue the Sales and Use Tax Exclusion agreement awarded on
November 19, 2019**

Dear Honorable Directors,

Thank you very much for the opportunity to appear before you at the upcoming November 16 meeting of the Board. We respectfully disagree with and wish to appeal staff's recommendation to terminate our award, as we believe it would significantly interrupt the financing phase now in process for our project and harmfully impact our project timeline.

Since the time the CAEATFA Board voted to approve the extension to our STE program award in 2019, CE+P has run a gauntlet of milestones toward building Sugar Valley Energy, with only the sale of equity instruments and green bonds remaining. I have attached an updated list of milestones achieved and look forward to highlighting these accomplishments in person at the meeting.

With this financing process scheduled to close in Q1 of 2022, we anticipate the purchasing process for the required Qualifying Purchases will proceed throughout calendar years 2022 and 2023. As our existing 2019 award provides us until December 2023 to make these purchases, we stipulate that we will not require another extension.

since the November 2020, CAEATFA Board Update

- **December 2020:** Finalized the Ethanol Purchasing/Marketing Agreement with CHS, Inc. (\$30+ billion annual revenue agriculture cooperative) who will market our ethanol into the California market
- **January 2021:** Received second party opinions from Kestrel Verifiers that the bonds being issued will be certified as Green Bonds
- **June 2021:** Agreed to all terms, conditions and costs with Booker-Tate Limited, the Owners Engineer during construction
- **June 2021:** IHS Markit finalized an updated detailed market report for the project's revenue projections
- **July 2021:** Formally filed an application with CDLAC to obtain benefits under their bond financing program
- **August 2021:** Received a draft of the project's proposed Operating & Maintenance/ Asset Management agreement with IHI Power Services
- **October 2021:** Agreed to all terms, conditions and costs with Constellation/Exelon who will market both our electricity and biogas into the California market

- **October 2021:** Finalized the project's Independent Engineering report with Black & Veatch

As the Assemblymember representing the 56th District, which includes the County of Imperial, I write this letter in support of the Sugar Valley Energy project, and the continuation of the sales and use tax exclusion (STE) award for the project. Once completed this project will serve to boost the local economy, while simultaneously advancing low carbon fuels, which will serve to help the State progress towards our greenhouse gas emission goals.

Imperial County, where this project will be located, historically has some of the highest unemployment rates in the Nation; the Sugar Valley project will create an estimated 10,000 jobs and over \$900 million in economic activity.
