

## Estimated Timeline – Adoption of CalSavers Regulations

### **SUMMARY**

Late-September 2018	Begin formal rulemaking process for emergency regulations
Late-October 2018	Begin formal regular rulemaking process for permanent regulations
Winter 2018	Public comment period
Spring 2019	Permanent Regulations take effect
April 2019	First emergency regulations readoption (if necessary)
July 2019	Second emergency regulations readoption (if necessary)
Late-September 2019	Emergency regulations expire (deadline to complete permanent rulemaking)

### **EMERGENCY RULEMAKING**

September 24, 2018	Board approval to approve proposed regulations
September 25, 2018	Notice of emergency action
October 1, 2018	Submit Regulations Package to OAL <ul style="list-style-type: none"><li>• Initiate 5-calendar day public comment period</li><li>• Initiate 10-calendar day OAL review</li></ul>
October 5, 2018	Public comment period ends
October 12, 2018	OAL Review Period Ends
October 15, 2018	Emergency Regulations Effective
Mid-April, 2019	Emergency Regulations expire – first 90-day readoption
Early-July, 2019	Emergency Regulations expire – second 90-day readoption
Early-October, 2019	Emergency Regulations expire

## Estimated Timeline – Adoption of CalSavers Regulations

### REGULAR RULEMAKING

November 1, 2018                      Submit Notice of Proposed Action with OAL to be posted in register October 19 (must be submitted by Tuesday of week prior to Friday posting)

November 12, 2018                      The *Rulemaking File* and Notice of Publication are filed with the Office of Administrative Law (OAL). The Notice of Proposed Regulatory Action is issued. Publication and issuance of notice to initiate 45-day\* public comment period.

December 27, 2018                      45-day public comment period ends.

Early-January, 2019                      Public hearing.

Late-January, 2019                      Respond to public comments; Deliver package to OAL

Early-March, 2019                      Deadline for OAL review. If approved, OAL issues Approval of Certificate of Compliance for permanent regulations and files regulations with the Secretary of State

Early-March, 2019                      Regulations become effective upon filing.

\*If public comments are received that warrant substantial modifications to the proposed regulations, then the process will be lengthened to accommodate either a 15-day or 45-day comment period as follows:

Late-January, 2019                      Regulation modifications are made and Notice of Proposed Changes is issued to initiate a 15-day comment period.

Mid-February, 2019                      15-day comment period ends.

Early-March, 2019                      Deliver permanent regulation package to OAL for 30-day review.

Early-April, 2019                      Deadline for OAL review. If approved, OAL issues Approval of Certificate of Compliance for permanent regulations and files regulations with the Secretary of State; Regulations effective upon filing

\*Or, if public comments are received that warrant major changes, a new 45-day notice is required.

Mid-March, 2019                      End of new 45-day public comment period.

Early-April, 2019                      Deliver permanent regulation package to OAL for 30-day review.

Deadline for OAL review. If approved, OAL issues Approval of Certificate of Compliance for permanent regulations and files regulations with the Secretary of State; Regulations effective upon filing
