#### CALSAVERS RETIREMENT SAVINGS BOARD

Executive Director's Report

### **Board Name**

With the passage of Assembly Bill (AB) 102 on June 29, 2020, the Board's name is now the CalSavers Retirement Savings Board, bringing it into conformity with the Program name.

#### **Update on COVID-19 Response**

The pandemic continues to pose challenges for the workers CalSavers exists to serve, as well as for their employers. This summary updates the report provided to the Board on April 15, 2020.

#### **Program Business Continuity**

- Staff telework and internal operations
  - o Largest impact on field and promotional work; effective shift
  - o Return to office planning underway with State Treasurer's Office
  - o State employee compensation reduction and furloughs
- Ascensus operations and customer service

#### Savers Impact

## **Review of Program Participation and Funding**

The Summary of Program Participation and Funding for the quarter ending June 30, 2020 is included as Attachment 1. Highlights include:

- More than doubled the number of funded accounts during the second quarter, from 5,944 as of March 31 to 15,120 as of June 30. (Chart 2)
- Despite a slow-down in new employer registrations, nearly doubled the number of employers who started payroll deductions by directing more onboarding support to employers that had already been registered but had not yet started facilitating payroll deductions. (Chart 1)

- Savers contributed more than \$1.5 million per month by the end of the quarter, with the first employer deadline still three months away. (Snapshot)
- The rate of full withdrawals measured as a percent of all payroll contributing accounts declined from 9.6% as of March 31 to 7.2% as of June 30. (Chart 8)

# **Budget**

As of May 31, 2020, the most recent available reporting, the program had spent \$1,232,321 in loan funding in fiscal year 2019-20 and a total of \$4.9 million since inception. A detailed budget summary is included as Attachment 2.

# **Contracts Executed Under Delegated Authority and Upcoming Contracts/Renewals**

# Translation Services

Staff released Request for Qualifications (RFQ) No. CSCRSIB06-19 for external translation services on March 6, 2020. These services were previously provided under a contract with STC Interpreting. After evaluating all proposals, staff selected Interpreters Unlimited to provide translation services to the CalSavers Program. The agreement with Interpreters Unlimited took effect on June 22, 2020 and the term is two years with an optional one-year extension, for a maximum value of \$150,000 if the extension is exercised. Payments will only be allowed for work performed. Under the prior contract, the Program spent a total of \$3,608.50 during the one year term.

# Program Fund Audit

Staff expect to release RFP No.CRSB01-20 on July 24, 2020 to solicit bids for external auditing services of the Program Fund of the CalSavers Retirement Savings Trust, which includes the assets held by program participants. The resulting agreement with the selected contractor will be for audits of fiscal years 2019-20 and 2020-21, with an option for the Board to extend for one additional fiscal year report, for a maximum total contract value of \$225,000 if the option is exercised.

#### **Investment Consultant Services**

The current agreement with Meketa Investment Group, Inc., the current investment consultant, is set to expire on January 9, 2021. Staff is currently developing a Request for Proposals (RFP) to solicit bids to provide these services under a new agreement, with adjustments to account for current needs. The draft RFP is included as Attachment 3 and the tentative procurement schedule is shown below.

As in previous procurements for important board services, and consistent with the governance policy and the Bagley-Keene Open Meeting Act, two board members may volunteer to join the staff evaluation committee. Staff will recommend a firm to the Board for approval at the September Board meeting, currently scheduled for September 28.

# **Legislation and Policy Update**

State Legislation

Assembly Bill (AB) 102 was signed into law by Governor Newsom June 29, 2020. The legislation makes a variety of changes to statute related to CalSavers, including:

- Transitioning authority to enforce employer compliance from the Employment Development Department (EDD) to the Franchise Tax Board (FTB);
- Changing the name of the Board and trust to conform with the program name;
- Authorizing cannabis regulation agencies to share licensee data with the Board;
- Allowing the Board the option to implement the "open enrollment" or re-solicitation feature, rather than have it be a mandatory feature; and
- A variety of amendments to update obsolete language and improve clarity.

The Board approved all but one of these statutory changes at the November 19, 2019 Board meeting. At the April 15, 2020 meeting, the Board adopted a resolution endorsing the transition of duties to enforce employer compliance from the Employment Development Department (EDD) to the Franchise Tax Board (FTB).

Additional detail on the transition of employer enforcement duties will be provided later in the agenda.

# Federal Policy

<u>DOL</u> on the Inclusion of Private Equity Strategies in DC Plans: Through an information letter issued June 3, 2020, the U.S. Department of Labor (DOL) concluded that private equity strategies can be included in defined contribution plan investments covered under the Employee Retirement Income Security Act (ERISA). The letter stipulates fiduciaries would need to consider how including such a strategy would impact diversification of risks.

<u>DOL</u> on the Inclusion of ESG in ERISA Plans: DOL issued a proposed rulemaking June 23, 2020 that clarifies plan fiduciaries covered under ERISA may only make investment decisions based on economic factors. The regulation specifically refers to ESG investment options and would require plan fiduciaries to document whenever it deems an alternative investment option like an ESG fund to be economically indistinguishable from an investment fund that does not consider ESG principles. The rule would prohibit ESG investments to be set as the default investment in an ERISA plan.
