Executive Director's Report

Staffing

Effective October 1, 2020, Carolina Hernandez was promoted from Staff Services Analyst to Associate Governmental Program Analyst in recognition of her outstanding support of the Program's outreach strategy and increasing Program needs in this vital area.

In September, the State Treasurer's General Counsel hired Senior Attorney Jennifer Baldwin, whose portfolio will include the CalSavers Retirement Savings Board. Ms. Baldwin previously served as a deputy legislative counsel in the Office of Legislative Counsel.

Update on COVID-19 Response

Business continuity in the face of the coronavirus pandemic remains strong, both internally with Board staff and externally with contractors. On August 3, 2020 staff implemented the State Treasurer's Office's return to the office plan, with some staff rotating between telework and in-office work and others continuing full-time telework.

Review of Program Participation and Funding

The employer registration deadline on September 30, 2020 drove substantial growth in employer activity, which will largely manifest in growth in funded accounts in December and into 2021. The Executive Director will present highlights of recent growth, as detailed in the full Summary of Program Participation and Funding as of October 12, 2020, included as Attachment 2A.

Budget

As of June 30, 2020, the most recent available reporting, the program spent \$1.4 million in loan funding in fiscal year 2019-20 and a total of \$5.0 million since inception in November 2016. A detailed budget summary is included as Attachment 2B.

Contracts Executed Under Delegated Authority and Upcoming Contracts/Renewals

Program Fund Audit

Staff released Request for Proposals (RFP) No.CRSB01-20 on July 24, 2020 to solicit bids for external auditing services of the Program Fund of the CalSavers Retirement Savings Trust, which includes the assets held by program participants. After evaluating all proposals, staff selected CliftonLarsonAllen, LLP, based on the firm's specialized services and experience with retirement and pension plan compliance, its national reputation, and its ability to scale with the CalSavers Program as it grows. The agreement with CliftonLarsonAllen, LLC will take effect

upon final approval from the Department of General Services (DGS), expected in late October, 2020 and the term of the agreement will be from the DGS approval date through June 30, 2022, with an option to extend one additional year. The maximum value of the agreement is \$134,524 for two years, or \$204,162 if the extension is exercised.

Interagency Agreement with the Franchise Tax Board

As reported during the Board meeting on July 27, 2020, staff are developing an Interagency Agreement (IA) with the Franchise Tax Board to establish the terms under which FTB will implement the employer compliance enforcement program. Staff intend to present the proposed IA to the Board for approval at the next meeting.

Annual Call Center Staffing Model Update

During its meeting on September 23, 2019, the Board directed the Executive Director to update the Board annually on models for providing customer service. Specifically, staff were directed to analyze costs and benefits of continuing to provide this service via the program administrator compared to operating the function in-house with state employees, including revised fee impact analysis informed by the latest knowledge of program participation and growth projections.

Staff conducted extensive analysis based on new data and estimated that a substantial increase in participant fees would still be required to bring the customer service function in-house in the early years, with the difference in fees declining as the Program grows to scale. Based on this analysis, staff conclude that the issue should be reconsidered next year.

As the Program grows, the financial model and assumptions will be refined based on participation and customer service utilization and, per the Board's direction, staff will continue to revise the analysis and update the Board annually.

Legislation and Policy Update

Regulations

During the next Board meeting, staff will present a package of proposed regulations to address the following topics:

- Enforcement of employer compliance
- Re-adoption of current emergency regulations
- Reduction of the minimum contribution amount for non-payroll contributions (already approved by the Board, but a technical update is required)
- Change to the information required for individuals to opt-out of the Program by phone using the interactive voice response system
- Change to the default investment, pending Board direction

State Legislation

Assembly Bill 323 (Rubio), approved by the Governor on September 30, 2020, requires state departments to publish an annual report of each year's payments for placements of marketing or outreach advertising material. Staff are evaluating how this law will affect CalSavers and its contractors.

Federal Policy

<u>DOL</u> on the Inclusion of ESG in ERISA Plans: On July 30, 2020, the comment period closed for a proposed rulemaking issued by the U.S. Department of Labor (DOL) on June 23, 2020. The proposal clarifies plan fiduciaries covered under ERISA may only make investment decisions based on economic factors. The regulation specifically refers to ESG investment options and would require plan fiduciaries to document whenever it deems an alternative investment option like an ESG fund to be economically indistinguishable from an investment fund that does not consider ESG principles. The rule would prohibit ESG investments to be set as the default investment in an ERISA plan.
