# Legislation and Policy Update

California Legislation

- Budget Acts of 2021: Assembly Bill (AB) 214 and Senate Bill (SB) 112 would change startup loan repayment dates to 2024
- Monitoring AB 470 (Carrillo): elimination of asset tests for Medi-Cal eligibility

# CalSavers Regulations

- New Emergency Regulations: Emergency regulations changing the default investment option, clarifying the processes for enforcing employer compliance, and reducing the minimum contributions amounts for non-payroll were approved by the Office of Administrative Law (OAL) on January 25, 2021.
- Readoption of Existing Emergency Regulations: Readoption of current emergency regulations extending the first employer deadline from June 30, 2020, to September 30, 2020, were approved by OAL on February 17, 2021 (see also agenda item 5).
- Regular Rulemaking: On March 8, 2021, staff initiated regular rulemaking for the two sets of emergency regulations described above.

- U.S. Department of Labor on the Inclusion of ESG (environmental, social, and governance factors) in ERISA Plans: Mach 10, 2021 announcement of suspension of enforcement of new rule pending review
