Review of Program Participation and Funding

- In calendar year 2021 (as of early December):
 - o Saver assets **grew five-fold**, from \$28 million to more than \$155 million
 - The number savers more than **doubled** from 96,000 to 210,000
 - o The number of registered employers **tripled**, from 7,300 employers to 22,000.

Update on Employer Compliance Enforcement

• Staff began to distribute due process notices for non-compliant Wave 1 employers (employers with more than 100 employees) in early September. The status of these employers by type of compliance failure is as follows:

In Home Support Services (IHSS) Provider Inclusion Update

- Ongoing research and analysis prescribed in Government Code Section 100046(a):
 - 1. The inclusion meets all state and federal legal requirements.
 - 2. The appropriate employer of record has been identified for the purpose of satisfying all the program's employer requirements.
 - 3. The payroll deduction can be implemented at reasonable costs.
 - 4. The inclusion does not create a financial liability for the state or employer of record.
- Engagement with labor union leaders, Department of Finance, Department of Social Services

Legislation and Policy Update

California Legislation

• Possible 2022 legislative amendments are under consideration.

CalSavers Regulations

- Regular Rulemaking: Staff began the regular rulemaking process in March 2021 to make permanent three sets of emergency regulations amendments. Since the start of the summer, staff have been working with the Department of Finance to refine the economic and fiscal impact analysis for the regulations package. Staff submitted the rulemaking package December 1, 2021.
- Readoption of Existing Emergency Regulations: At the previous Board meeting, the Board approved the readoption of emergency regulations amendments initially approved at the December 7, 2020 meeting that, among other things, changed the default investment option. The readoption was approved by the Office of Administrative Law November 17, 2021.

Federal Rulemaking & Legislation

- U.S. Department of Labor on the Inclusion of ESG (environmental, social, and governance factors) in ERISA Plans: The U.S. Department of Labor began a rulemaking effort in October 2021 regarding prudence and loyalty in selecting plan investments. The rulemaking is in response to regulations adopted during the Trump Administration that many interpreted to limit the use of ESG investment options in ERISA plans. The rule would clarify how ERISA's fiduciary duties apply to ESG investments. Currently, the DOL is accepting public comments on the rulemaking. The comment period closes December 13, 2021.
- The House Ways and Means Committee approved addition of legislation to the Build Back Better Act in early September that would have a) established a requirement that employers sponsor a retirement plan or provide their employees access to an individual retirement account (IRA) with automatic enrollment; and b) made the savers credit refundable. Those provisions were later removed from the act. On November 19, 2021 the House passed a version of the Build Back Better Act. The act includes some provisions addressing the use of IRAs as tax shelters for the wealthy.
- Staff continue to monitor other federal retirement legislation, including Securing a Strong Retirement Act "SECURE Act 2.0," Enhancing Emergency and Retirement Security Act, the RISE UP Act and other legislation relevant to the Program.
