## **Review of Program Participation and Funding**

## **Update on Employer Compliance Enforcement**

Wave 1 Employers (more than 100 employees; registration deadline September 30, 2020):

- In early September 2021, following dozens of mail and email notices sent by program administrator Ascensus over the last two and a half years, staff began to directly distribute statutorily required due process notices for non-compliant Wave 1 employers. Three due process notices are required at least 90, 60, and 30 days prior to penalty imposition.
- Concurrently, staff undertook an aggressive campaign to reach these employers directly by phone and email, as well as conduct research to identify exempt employers via other documentable information. This staff outreach and research work proved to be effective and remains ongoing.
- In January, staff began transferring employer lists to the Franchise Tax Board (FTB) for penalty imposition. The status of these employers by type of compliance failure is as follows:

Wave 2 Employers (more than 50 employees; registration deadline June 30, 2021):

- By the end of February 2022, staff will commence targeted research and outreach (as described above for Wave 1) for non-compliant Wave 2 employers.
- In April 2022, staff will begin sending statutorily required due process notices for Wave 2 employers.
- Staff plan to transfer Wave 2 employer lists to FTB in September 2022.

#### **Budget**

- As of December 31, 2021, the most recent available reporting, the program had spent \$501,990 in loan funding in fiscal year 2021-22 and a total of \$7.5 million since inception in November 2016. (Detailed budget summary in Attachment 2B)
- Status of Budget Change Proposal (BCP): the requested \$6 million additional loan authority available for drawdown until June 30, 2024 and three new positions were included in the Governor's proposed budget and the Senate and Assembly budget bills introduced in January.

## **Contracts Executed Under Delegated Authority and Upcoming Contracts/Renewals**

- **ESG Investment Manager search**: RFP CRSB01-22, for a new investment manager for the ESG (environmental, social, and governance factors) option, was posted on February 18. Proposals are due on March 25.
- **Translation Services extension**: Processing an amendment to Agreement CSCRSIB06-19 with Interpreters Unlimited for translation and design services, to add one year to the term of the contract, which would expire on April 22, 2022. Current expenditures total \$24,135, or 24 percent of the maximum agreement amount of \$100,000.

#### In Home Support Services (IHSS) Provider Inclusion Update

- Ongoing research and analysis prescribed in Government Code Section 100046(a):
  - 1. The inclusion meets all state and federal legal requirements.

- 2. The appropriate employer of record has been identified for the purpose of satisfying all the program's employer requirements.
- 3. The payroll deduction can be implemented at reasonable costs.
- 4. The inclusion does not create a financial liability for the state or employer of record.
- Engagement with labor unions, Department of Finance, Department of Social Services

## **Legislation and Policy Update**

## California Legislation

- Discussion of Senate Bill 1126, which would expand program eligibility, will be covered later in agenda.
- Senate Bill 840 and Assembly Bill 1624 introduced January 10, 2022. Each bill includes a \$6 million appropriation for the CalSavers Retirement Savings Board and provides the Department of Finance authority to approve establishment of up to three staff positions to support the Program. At the time this item was written, each bill had been introduced and referred to the budget committee in their respective house.

### CalSavers Regulations

- Regular Rulemaking: The Board's regular rulemaking package, which made permanent three separate emergency rulemakings, was approved by the Office of Administrative Law January 13, 2022.
- Emergency Rulemaking: At the December 13, 2021 meeting, the Board approved emergency regulations amendments to adjust sections related to employer registration deadlines. Staff plan to begin the rulemaking March 1, 2022 and expect the regulations to take effect in mid-March 2022. Staff are currently developing the economic and fiscal impact analysis for the regulations.

## Federal Rulemaking & Legislation

- U.S. Department of Labor on the Inclusion of ESG (environmental, social, and governance factors) in ERISA Plans: The U.S. Department of Labor began a rulemaking effort in October 2021 regarding prudence and loyalty in selecting plan investments. The rulemaking is in response to regulations adopted during the Trump Administration that many interpreted to limit the use of ESG investment options in ERISA plans. The rule would clarify how ERISA's fiduciary duties apply to ESG investments. The public comment period closed December 13, 2021. At the time this item was written, a final rule had not yet been introduced.
- Staff continue to monitor other federal retirement legislation, including Securing a Strong Retirement Act "SECURE Act 2.0," Enhancing Emergency and Retirement Security Act, the RISE UP Act and other legislation relevant to the Program and retirement security in general.
