# I. TOPICS TO BE PRESENTED DURING MEETING

#### **Staffing**

## **Update on Employer Compliance Enforcement**

State law established penalties for eligible employers that do not make the Program available to their employees. For each wave of employers, after months of notices, staff begin distribution of enforcement notices ("due process notices") to employers who are not compliant due to missing their registration deadline, failing to upload their employee roster, or failing to facilitate contributions.

State law requires a series of three due process notices at least 90, 60 and 30 days prior to penalty imposition. Following these notices and extensive staff research efforts to identify exempt employers, staff transfer employers to the Franchise Tax Board (FTB) for penalty imposition. Staff will begin a new round of due process notices in the coming weeks for all waves that have passed a registration deadline, which will represent a significant expansion of enforcement efforts to date.

# **Eligible Employee Identification Verification**

At the November 2022 Board meeting, staff discussed efforts to refine the identity verification process for eligible employees. The program administrator, Ascensus, will provide additional detail on those efforts, which have led to improvements in the process that will ensure fewer


employees fail the identity verification process while ensuring the process remains in adherence with industry best practices and federal laws.

### **Demographic Data Collection**

Staff have identified the data fields to use for a voluntary effort to estimate the race, ethnicity, and gender breakdown of participating savers; Ascensus is currently evaluating scope of project.

# **Contracts / Interagency Agreements / Amendments**

Exceeding \$300,000 or Otherwise Requiring Board Action

- 1. Employer Enforcement Services Amendment with Franchise Tax Board (FTB): under final review at FTB
- 2. Investment Consultant: Authority to issue RFP to be considered at August Board meeting. Full RFP build in progress (**Attachment 2E**).

Up to \$300,000 (Executive Director's Delegated Authority)

- 1. Interagency Agreement with Office of State Publishing (OSP): executed March 1, 2023
- 2. Program Consultant Agreement, new search: Request for Proposals (RFP) released on April 26, 2023, with Proposals due on May 25, 2023
- 3. Translation and Design Services: vendor selected, agreement in process.

4. External Program Fund Audit Services: RFP released on April 12, 2023, with Proposals due on May 1, 2023. Vendor Selection in progress.

# **Legislation and Policy**

California Legislation

• AB 1381 (Weber) Call Centers - As written on May 12, 2023, the bill would require that state contractors with call center services have at least 50% of call center work performed within California, and that at least 75% of such work be performed within California by 2027. The bill would have a significant impact on the Program. Staff have provided technical feedback to the author's office in conjunction with the chair's staff and similar programs for which the Treasurer serves as chair.

## CalSavers Regulations


- Regular Rulemaking (Annual Employer Deadlines): The Office of Administrative Law (OAL) approved the rulemaking on March 15, 2023.
- Amendments to Conform Regulations with SB 1126: Board approved amendments to conform with Senate Bill 1126 at the November 21, 2022, Board meeting; amendments approved by OAL and took effect January 1, 2023; staff initiated the regular rulemaking process to make the amendments permanent on March 24, 2023.

## Federal Rulemaking & Legislation

• U.S. Department of Labor on the Inclusion of Environmental, Social, and Governance (ESG) factors in ERISA Plans: Final rule took effect January 30, 2023; rule clarifies that plan sponsors can consider ESG factors when making investment decisions if the factors are relevant to the financial performance of the investments. President Biden issued first veto of presidency in March for a bill that would have overturned the rulemaking.
