





Chart 1: Funded Accounts






Chart 2: Total Assets (millions)







Chart 3: Average Funded Account Balance

Chart 4: Distribution of Accounts by Balance







Chart 5: Monthly Contributions Per Saver

Chart 6: Status of All Registered Employers






Chart 7: Status of Post-Deadline Employers






Chart 8: Accounts w/ Full Withdrawal as % of Payroll Contributing Accounts
