






Chart 2: Total Assets

As of 5/31/22







Chart 3: Average Funded Account Balance As of 5/31/22

Chart 4: Distribution of Accounts by Balance As of 5/31/22






Chart 5: Monthly Contributions Per Saver As of 5/31/22






Chart 6: Status of All Registered Employers As of 5/31/22







Chart 7: Employer Status by Wave
