

ConduitFinancing	(R11)Ent-OtherOperatingRevenuesAdditions	Revenue consists of two items: 1) Intrastate fees related to College Access Tax Credit, and 2) payment from CA Health Facilities Financing Authority for time spent by CEFA staff working on CHFFA.
ConduitFinancing	(R54)Ent-NetPosition(Deficit)EndofFiscalYear	Deficit Net Position is a result of expenditures exceeding revenues in prior years primarily due to the recording of pension and OPEB related liabilities for the implementation of GASB 68 and 75, respectively. 2019 positive operational results were not significant enough to offset the accumulated deficit.
ProprietaryFunds	(R01)Entpr-Unrestricted	Decrease in cash is mainly related to higher receivables balance at 6/30/19. Receivables for fees related to bonds issued and outstanding increased ~\$231K over the prior year end, indicating less cash received during the fiscal year.

ProprietaryFunds	(R66)Entpr-TotalNetPosition(Deficit)	Deficit Net Position is a result of expenditures exceeding revenues in prior years primarily due to the recording of pension and OPEB related liabilities for the implementation of GASB 68 and 75, respectively. 2019 positive operational results were not significant enough to offset the accumulated deficit.
