Peer Respite Care Grant Program Resolution No. PR 2016-04B County of Trinity

December 5, 2019

PURPOSE OF THE REQUEST:

The County of Trinity (the "County") is requesting the Authority to approve Resolution No. PR 2016-04B to amend the project description as described in the originally approved Resolution No. PR 2016-04 awarding the County funds to develop a Peer Respite Care ("PRC") program (Attachment 1).

ISSUE:

Resolution No. PR 2016-04 expired on May 31, 2018, which approved a project description that required the County's PRC program to operate 24 hours per day, seven days per week. Shortly after opening the PRC program, the County faced financial challenges to staff the program 24 hours per day, seven days per week. The PRC program was forced to close in July 2018, due to funding constraints and reopened on July 1, 2019 with a new staffing plan and reduced operating hours. The PRC program currently operates five days a week, 24-hours per day Monday-Friday. If approved, this resolution will amend the project description, allowing the County to operate the PRC program based on the County's needs and demand for PRC program services.

BACKGROUND:

On May 26, 2016, the Authority approved Resolution No. PR 2016-04 to develop a new 4-bed PRC program to provide peer support services for adults 18 and older in an amount not to exceed \$750,000. Grant funds were approved for construction, purchase of furnishings and equipment, and for information technology costs. The County built a 6-bed PRC on county-owned land, which began offering services on April 30, 2018, and is operated by Trinity County Behavioral Health Services.

RECOMMENDATION:

Staff recommends the Authority approve Resolution No. PR 2016-04B.

A RESOLUTION OF THE CALIFORNIA HEALTH FACILITIES FINANCING AUTHORITY APPROVING EXECUTION AND DELIVERY OF GRANT FUNDING UNDER THE PEER RESPITE CARE GRANT PROGRAM TO THE COUNTY OF TRINITY

WHEREAS, The California Health Facilities Financing Authority (the "Authority"), a public instrumentality of the State of California, is authorized by SB 75 (Stats. 2015, Ch. 18, Sec. 55) and implementing regulations (California Code of Regulations, Title 4, Division 10, Chapter 6 (commencing with Section 7210)) to award grants for capital funding to finance eligible projects for peer respite care; and

WHEREAS, Authority staff reviewed the application submitted by County of Trinity ("Grantee") against the eligibility requirements of the Peer Respite Care Grant Program and recommends approval of a grant in an amount not to exceed \$750,000.00 for the eligible project (the "Project");

NOW, THEREFORE, BE IT RESOLVED by the California Health Facilities Financing Authority as follows:

<u>Section 1.</u> The Authority hereby approves a grant in a total amount not to exceed \$750,000.00 to complete the Project as described in the Grantee's application and as more particularly described in Exhibit A to this Resolution (Exhibit A is hereby incorporated by reference) within a project period that ends on December 31, 2017.

Section 2. The Executive Director is hereby authorized, for and on behalf of the Authority, to approve any minor, non-material changes in the Project described in the application submitted to the Authority and extend the project period completion date identified in Section 1 as authorized under the Peer Respite Care Grant Program. Nothing in this Resolution shall be construed to require the Authority to provide any additional funding, even if more grants are approved than there is available funding. Any notice to the Grantee shall indicate that the Authority shall not be liable to the Grantee in any manner whatsoever should such funding not be completed for any reason whatsoever.

Section 3. The Executive Director is hereby authorized and directed, for and on behalf of the Authority, to disburse funds not to exceed those amounts approved by the Authority for the Grantee. The Executive Director is further authorized and directed, for and on behalf of the Authority, to execute and deliver to the Grantee any and all documents necessary to complete the disbursement of funds that are consistent with the Peer Respite Care Grant Program.

Section 4.	The Executive Director of the Authority is hereby authorized and
directed to do any	and all things and to execute and deliver any and all documents which the
Executive Directo	r deems necessary or advisable in order to effectuate the purposes of this
