Summary of Project:

The County of Fresno (the "County") will construct an eight-bed Youth Crisis Stabilization unit and expand the existing adult Crisis Stabilization unit by eight beds. These units will be part of a broader project that will include an additional 16-bed Youth Psychiatric Health Facility (PHF), and a 10-bed Medical Triage and Sobering Center. The County is envisioning a unified sub-campus where critical social and community support services are co-located providing an effective service model for existing county conditions. The current campus includes a 16-bed adult PHF, a 12-bed adult Crisis Stabilization unit, and the County's outpatient mental health and substance use disorder services for adults. A broad-based coalition of community stakeholders is working together to address mental health care challenges in Fresno and implement costeffective and resource efficient solutions. The crisis stabilization program would provide greater access and capacity to serve an additional 4,713 clients annually. The County anticipates that the program will be operational by November 1, 2014. Grant funds will be used to construct and renovate the Youth and Adult Stabilization units and to equip and furnish them. The proposed funding is less than the requested amount because the Authority has deemed some costs ineligible and the amount represents the totality of remaining funding for the region after higher scoring applications are funded. The County has identified alternative funding sources in order to implement the Crisis Stabilization programs as envisioned. The difference in funding needed to implement the program as proposed is committed by the County through Mental Health Realignment, EPSDT and MHSA funds. Staff is assured that these resources are feasible and the project has the capacity to generate sufficient revenue to sustain its activities.

A RESOLUTION OF THE CALIFORNIA HEALTH FACILITIES FINANCING AUTHORITY APPROVING EXECUTION AND DELIVERY OF GRANT FUNDING UNDER THE INVESTMENT IN MENTAL HEALTH WELLNESS GRANT PROGRAM TO THE COUNTY OF FRESNO

WHEREAS, The California Health Facilities Financing Authority (the "Authority"), a public instrumentality of the State of California, is authorized by the Investment in Mental Health Wellness Act of 2013 (Welfare and Institutions Code Section 5848.5, "Act") and implementing regulations (California Code of Regulations Title 4, Division 10, Chapter 5 (commencing with Section 7113)) to award grants for capital funding and personnel funding to finance eligible projects; and

WHEREAS, Authority staff reviewed the application submitted by County of Fresno ("Grantee") against the eligibility requirements of the Act and implementing regulations and, pursuant to the Act and implementing regulations, recommends approval of a grant in an amount not to exceed \$794,795.45 for the eligible project (the "Project"), which consists of no more than \$794,795.45 for crisis stabilization capital costs;

NOW THEREFORE BE IT RESOLVED by the California Health Facilities Financing Authority, as follows:

- Section 1. The Authority hereby approves a grant in a total amount not to exceed \$794,795.45 to complete the Project as described in the Grantee's application and as more particularly described in Exhibit A to this Resolution (Exhibit A is hereby incorporated by reference) within a project period that ends on July 31, 2015.
- Section 2. The Executive Director is hereby authorized for and on behalf of the Authority to approve any minor, non-material changes in the Project described in the application submitted to the Authority and extend the project period completion date identified in Section 1 as authorized under the Act and implementing regulations. Nothing in this Resolution shall be construed to require the Authority to provide any additional funding, even if more grants are approved than there is available funding. Any notice to the Grantee shall indicate that the Authority shall not be liable to the Grantee in any manner whatsoever should such funding not be completed for any reason whatsoever.
- Section 3. The Executive Director is hereby authorized and directed, for and on behalf of the Authority, to disburse funds not to exceed those amounts approved by the Authority for the Grantee. The Executive Director is further authorized and directed, for and on behalf of the Authority, to execute and deliver to the Grantee any and all documents necessary to complete the disbursement of funds that are consistent with the Act and implementing regulations.

<u>Section 4.</u> The Executive Director of the Authority is hereby authorized and directed to do any and all things and to execute and deliver any and all documents which the Executive Director deems necessary or advisable in order to effectuate the purposes of this Resolution and the transactions contemplated hereby.

<u>Section 5.</u> This Resolution expires July 31, 2015.
