

NOTICE OF PUBLIC HEARING

Notice is hereby given pursuant to Section 147(f) of the Internal Revenue Code of 1986, as amended, that a public hearing will be held before the Executive Director of the California Pollution Control Financing Authority (the "Authority") or a designee on Friday, May 19, 2023, at 10:00 a.m., California time, or as soon thereafter as such matters may be heard, in Room 270 of 801 Capitol Mall, Sacramento, California 95814, on the proposed issuance by the Authority of one or more series of tax-exempt revenue bonds in an aggregate principal amount not to exceed \$144,205,000 (the "2023 Bonds"), to refinance qualified solid waste disposal facilities as defined in Section 142(a)(6) of the Code.

Proceeds of the 2023 Bonds will be applied to the refunding of all of the outstanding California Pollution Control Financing Authority Solid Waste Refunding Revenue Bonds (Republic Services, Inc. Project) Series 2010A (AMT) (the "2010A Bonds"), previously issued in the aggregate principal amount of \$144,205,000. Proceeds of the 2010A Bonds were used to refund all or a portion of the Authority's previously issued (i) \$57,000,000 aggregate principal amount Solid Waste Revenue Bonds (Keller Canyon Landfill Company Project), Series 1992 (the "1992 Bonds"); (ii) \$28,000,000 aggregate principal amount Solid Waste Disposal Revenue Bonds (Browning-Ferris Industries of California, Inc. Project), Series 1996A (the "1996 Bonds"); (iii) \$25,000,000 aggregate principal amount Solid Waste Disposal Revenue Bonds (Browning-Ferris Industries of California, Inc. Project), Series 1997A (the "1997A Bonds"); (iv) \$35,000,000 aggregate principal amount Environmental Improvement Revenue Bonds (Browning-Ferris Industries of California, Inc. Project), Series 1997B (the "1997B Bonds"); and (v) \$30,000,000 aggregate principal amount Solid Waste Disposal Revenue Bonds (Republic Services, Inc. Project), Series 2003 (the "2003 Bonds").

Proceeds of the 1992 Bonds were used to finance the acquisition, construction, improvement, installation and equipping of certain solid waste disposal facilities and related equipment at the Keller Canyon Landfill located at 901 Bailey Road, Pittsburg, California 94565.

Proceeds of the 1996 Bonds, the 1997A Bonds and the 1997B Bonds were used to finance the acquisition, construction, improvement, installation and equipping of certain solid waste disposal facilities and related equipment at the Sunshine Canyon Landfill located at 14747 San Fernando Road, Sylmar, California 91342.

Proceeds of the 2003 Bonds were used to finance the acquisition, construction, improvement, installation and equipping of various solid waste disposal facilities and related equipment, including the facilities and/or equipment located at (i) 4001 North Vasco Road, Livermore, California 94551; (ii) 1231 North Blue Gum Street and 1131 North Blue Gum Street, Anaheim, California 92805; (iii) 2059 Steel Road, Colton, California 92324; (iv) 2901 Industrial Court, Fairfield, California 94533; (v) Foot of Parr Boulevard, Richmond, California 94801; (vi) 3260 Blume Drive, Richmond, California 94806; (vii) 111 South Del Norte Boulevard, Oxnard, California 93030; (viii) 4213

Crooked Palm Road, Ventura, California 93001; (ix) 1449 Rosecrans Avenue, Gardena, California 90249; (x) 2495 East 68th Street, Long Beach, California 90805; (xi) 29201 Henry Mayo Drive, Valencia, California 91384; (xii) 1 Dump Road, Avalon, California 90704; (xiii) 12949 Telegraph Road, Santa Fe Springs, California 90670; and (xiv) 3300 Whiteside Street, Los Angeles, California 90063.

All facilities described above that are being refinanced by the 2023 Bonds are owned and/or principally used by Republic Services, Inc., a Delaware corporation (the "Company") and/or an affiliate thereof.

Notice is further given that at said hearing, all proponents and opponents of the proposed financing will have an opportunity to be heard on the question as to whether the 2023 Bonds should be issued.
