

RESOLUTION NO. 19-16

APPROVAL OF FINANCIAL SOUNDNESS DETERMINATION FOR INNOVATIVE HORIZONS CHARTER SCHOOL AT NAN SANDERS, LOCATED IN RIVERSIDE COUNTY FOR A PRELIMINARY/ADVANCED APPORTIONMENT THROUGH THE CHARTER SCHOOL FACILITIES PROGRAM

JUNE 12, 2019

WHEREAS, the Charter School Facilities Program (Program) was established (Statutes of 2002) for the purpose of providing charter schools with funding to construct new facilities and modernize old facilities; and

WHEREAS, modeled after the State's School Facilities Program, the Program funds 50 percent of facilities project costs as a grant from the State, and 50 percent as a matching share, which the charter school is responsible for providing or repaying to the State; and

WHEREAS, the California School Finance Authority (Authority) and the State Allocation Board (Board), staffed by the Office of Public School Construction, are jointly designated to administer this per-pupil facilities aid Program, and the Authority is authorized by Education Code section 17078.57 to determine whether applicants to the Program are financially sound for purposes of the Program at the time of Preliminary, Advance, and Final Apportionment; and

WHEREAS, Proposition 51, passed by California voters in November 2016, established an additional \$500 million for apportionments under the Program; and

WHEREAS, the Authority is required by section 10154 of Program regulations to conduct a review of Perris Elementary School District's financial soundness, on behalf of Innovative Horizons Charter School at Nan Sanders, at the time of its Preliminary/Advance Apportionment request, and determine whether it has maintained a financially sound status; and

WHEREAS, Perris Elementary School District will fulfill its local matching share obligation through lump sum contribution; and

WHEREAS, this determination of financial soundness will be provided to the Office of Public School Construction; and

WHEREAS, this determination of financial soundness is contingent upon there being no material legal, financial, or operational changes between the date of this resolution and Perris Elementary School District's receipt of apportionment.

NOW, THEREFORE, BE IT RESOLVED by the California School Finance Authority as follows:

Section 1. That Perris Elementary School District, on behalf of Innovative Horizons Charter School at Nan Sanders, has demonstrated its financial soundness for purposes of a Preliminary/Advance Apportionment in the amount of \$ 11,105,767.

Section 2. This determination as it relates to a Preliminary/Advance Apportionment is in place for twelve months and assumes no financial, operational, or legal material findings within this time period.

Section 3. The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to notify the Board and provide supporting documentation that Perris Elementary School District, on behalf of Innovative Horizons Charter School at Nan Sanders, has maintained its financial soundness for purposes of the Program and for its request for final release of funds.

Section 4. The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to execute the Program agreements between the State and Perris Elementary School District prior to any release of funds

Section 5. This resolution shall take effect immediately upon its approval, and be in effect for twelve month from the date of adoption.
