

Consent Calendar Item 11.d.9 Minutes:

Dr. Melendez considered an appeal requested by ICEF Inglewood Middle Charter Academy regarding the request for certification of good standing to the California School Finance Authority as follows:

By way of background, ICEF submitted a public funding application for the 2018-19 Charter School Facility Grant Program. The California School Finance Authority, which administers the program requested the District

provide a certification that ICEF was in good standing with the District and in compliance with its charter. The District determined that ICEF was not in good standing and declined to provide the requested certification.

On March 18, 2019, CSFA informed ICEF that it was ineligible for funding.

On May 20, 2019, ICEF requested an appeal of the District's determination pursuant to the regulations governing the grant program. Accordingly, Dr. Melendez considered ICEF's appeal of the District's determination that the Charter School is not in good standing within the meaning of the regulations.

The appeal was conducted as follows: ICEF was given five (5) minutes to present its position. Ms. Evans, District legal counsel, was present to address the issue.

Upon the conclusion of the appeal, a final decision as to whether to affirm or rescind the District's determination that ICEF is not in good standing with the District and not in compliance with its charter.

Dr. Melendez asked for Parker Hudnut from ICEF to provide his report regarding ICEF's request for certification of good standing to the California School Finance Authority.

At the conclusion of Mr. Hudnut's report Ms. Sue Ann Evans from Dannis Woliver Kelley explained the process described above.

Dr. Melendez extended her appreciation to Mr. Hudnut for his report and further provided her decision as follows:

The information presented was not sufficient to warrant a reversal of the District's original certification to the CSFA regarding ICEF's standing with the District being incorrect or erroneous.

ICEF's history of inadequate academic performance is the subject of findings issued March 6, 2019, in declining to renew the charter.

In light of the performance data and the requirements of the charter, Dr. Melendez did not find error in the District's determination. Accordingly, ICEF's appeal was denied.

Dear State Administrator Melendez:

We write now to provide this written statement in support of our appeal of the District Staff's decision to deny a certification of good standing pursuant to 4 CCR section 10170.3(f). As you are aware, the District's decision not to issue a certification of good standing to the California School Finance Authority has caused the California School Finance Authority to determine that ICEF Inglewood Middle Charter Academy (IIMCA) is not eligible to receive an award from the 2018-2019 Charter School Facility Grant Program.

Pursuant to 4 CCR section 10170.3(f), ICEF Inglewood Middle Charter Academy hereby appeals the IUSD Staff's certification to the California School Finance Authority that ICEF Inglewood Middle Charter Academy is not in good standing and not in compliance with its charter to the Inglewood Unified School District Governing Board.

#### Written Statement In Support Of Appeal

IIMCA has been able to demonstrate significant academic gains last year and this year with a renewed data-driven focus that justify a certification of good standing. Scaled Score data clearly demonstrates the accelerated growth that 8th graders made in 2018 over their time at IIMCA. These students performed well below their district counterparts at the beginning of their time with IIMCA in 2016 in ELA but <u>exceeded</u> district performance by 8th grade in 2018. To reiterate, IIMCA 8th graders overall outperformed IUSD and both resident schools (Crozier and Monroe) in ELA by the time they finished at IIMCA. Additionally, IIMCA's 8th grade African American subgroup also outperformed the state African American subgroup.

In Mathematics, the same trend is observed. IIMCA students performed below their district counterparts in 2016 as 6th graders but by 2018, IIMCA 8th graders overall outperformed Crozier and their performance was comparable to Monroe's (with a difference of 0.9). IIMCA's 8th grade African American subgroup outperformed both resident schools and IUSD.




In addition, seventy-one percent (71%) of IIMCA's 7th graders overall outperformed Crozier in both ELA and Math. The 7th grade African American subgroup's math performance was also above Crozier's.


In sum, data demonstrates that IIMCA sent better prepared 8th graders to high school than IUSD and IIMCA's resident schools. It also demonstrates the continued positive trajectory of students during their time at IIMCA.

The scale score data is shown in the figures below.


<u>African American</u> (87% of IIMCA) – When looking at the 8<sup>th</sup> grade cohort, in 2016, these students performed below their district counterparts. However, by the 2017-2018 school year, IIMCA 8<sup>th</sup> graders closed the gap between them and their district counterparts, performing above their level in both ELA and Math.








**Economically Disadvantaged African American** – IIMCA's Economically Disadvantaged African American subgroup demonstrates the same accelerated growth in both ELA and Math, in comparison to their district counterparts over a three-year period.







This data demonstrates the scale score growth IIMCA made overall, by grade level and within subgroups. In comparison, IIMCA's resident schools' performance is declining in most areas while IIMCA continued to grow overall and by grade level. IIMCA's demonstration of successful growth, while resident schools are declining, demonstrates that IIMCA supported the students at a more rapid pace academically.

We would note that while the State identifies the lowest 7% of schools using the Comprehensive Support and Improvement (CSI) criteria from the California Dashboard, it is noteworthy that IIMCA is not on this list, yet Crozier is identified here by the State. More significantly, Crozier is the school where seventyone percent (71%) of IUSD students at IIMCA would have otherwise attended.

The growth noted above was due to changes in the administration and teaching staff at IIMCA in the summer of 2017 that yielded significantly positive results. IIMCA staff provided a significant amount of information regarding these changes and the subsequent transformation that took place to District staff, which should have been considered by District staff. These changes have resulted in even more academic gains by IIMCA students that have continued through the 18-19 school year. As an example, by December 2018, 80% of IIMCA students had already achieved their annual growth target in reading, according to Achieve3000 (also used by IUSD).

#### Conclusion

IIMCA's data demonstrates and supports that students enrolled for multiple years <u>did</u> excel academically and were more prepared for high school than their counterparts at District and other schools. These academic gains should have been considered by District staff when they made the decision to deny a certification of good standing to IIMCA.



The District's decision to deny a certification of good standing to CSFA for IIMCA has had serious and immediate negative fiscal consequences for IIMCA. The grant award amounts to approximately \$120,000, and those grant funds were directly encumbered to reimburse IIMCA for lease costs for the 2018-2019 school year. Thus, the State grant program that provides lease reimbursements to IIMCA reflects money <u>already spent</u> during the 2018-2019 school year, a year when IIMCA students continue to make significant progress academically. There is no justification for the District's decision to deny a good standing certification to CSFA, and we respectfully request that this Board grant our appeal and find that the District must issue a certification of good standing for IIMCA to the CSFA.

We urge you to consider these factors when making your decision.
