## ADOPTION OF THE PROPOSED EMERGENCY REGULATIONS FOR THE CHARTER SCHOOL FACILITY GRANT PROGRAM

## March 30, 2023

**WHEREAS,** the Charter School Facility Grant Program (Program) provides annual assistance with facilities rent and lease costs for California charter schools that meet certain edibility and funding criteria, and

**WHEREAS**, the Program's regulations are revised from time to time to improve Program administration and access to funding; and

**WHEREAS**, the Authority is authorized through Education Code Section 47614.5(m) to adopt Program regulations as emergency regulations in accordance with the Administrative Procedure Act (Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of the Title 2 of the Government Code); and

**WHEREAS,** at this time, the regulations will be amended to be consistent with Program policy and procedure and clarify language.

**NOW, THEREFORE, BE IT RESOLVED** by the California School Finance Authority as follows:

<u>Section 1</u>. The proposed emergency regulations for the Program are hereby approved in substantially the form presented on this date.

**Section 2**. The Executive Director is hereby authorized, for and on behalf of the Authority, to submit such regulations, with any and all required supporting documentation, to the Office of Administrative Law and proceed as required under the Administrative Procedures Act.

<u>Section 3</u>. The Executive Director is hereby authorized to execute and deliver any documents and take any steps that the Executive Director may deem necessary or advisable in order to effectuate the purposes of this resolution.
