

RESOLUTION NO. 23-22

APPROVAL OF FINANCIAL SOUNDNESS DETERMINATION FOR SAN DIEGO UNIFIED SCHOOL DISTRICT ON BEHALF OF THE O'FARRELL CHARTER FOR FINAL APPORTIONMENT THROUGH THE CHARTER SCHOOL FACILITIES PROGRAM

WHEREAS, the Charter School Facilities Program (Program) was established for the purpose of providing charter schools with funding to construct new facilities and rehabilitate existing district facilities; and

WHEREAS, modeled after the State's School Facilities Program, the Program funds 50 percent of project costs as a grant from the State, and 50 percent as a loan, which the charter school or obligor is responsible for repaying to the Program; and

WHEREAS, the California School Finance Authority (Authority) and the State Allocation Board (Board), staffed by the Office of Public School Construction (OPSC), are designated to jointly administer the Program; and

WHEREAS, the Authority is authorized by Education Code section 17078.57 to determine whether applicants to the Program are financially sound for purposes of the Program at the time of Preliminary, Advance, and Final Apportionment; and

WHEREAS, the Authority is required by section 10154 of Program regulations to conduct a review of San Diego Unified School District (SDUSD) on behalf of The O'Farrell Charter' (TOC) financial soundness for purposes of a Final Apportionment; and

WHEREAS, the State Allocation Board, through the funding methodology established pursuant to Education Code section 17078.56, awarded SDUSD on behalf of TOC a Final Apportionment of \$59,547,614 for its Rehabilitation project; and

WHEREAS, San Diego Unified School District (SDUSD) will fulfill the project's local matching share obligation by providing a lump sum in the amount of \$29,773,807; and

WHEREAS, this determination of financial soundness will be provided to the Office of Public School Construction; and

WHEREAS, this determination of financial soundness is contingent upon there being no material legal, financial, or operational changes between the date of this resolution and SDUSD on behalf of TOC's receipt of apportionment.

NOW, THEREFORE, BE IT RESOLVED by the California School Finance Authority as follows:

Section 1. That SDUSD on behalf of TOC has demonstrated its financial soundness for purposes of a Final Apportionment.

Section 2. The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to notify the Board and provide supporting documentation, that SDUSD on behalf of TOC has maintained its financial soundness for purposes of the Program and for its request for final release of funds.

Section 3. The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to execute the Program agreements between the State, SDUSD, and TOC prior to TOC occupying the facility.

Section 4. This resolution shall take effect immediately upon its approval and be in effect for twelve months from the date of adoption.
