WHEREAS, the Charter School Facility Grant Program (Program) is established in Title 2 (commencing with Section 47614.5) of the Education Code and administered by the Authority to provide annual assistance with facilities rent and lease costs for California charter schools that meet certain edibility and funding criteria, and

WHEREAS, Education Code Section 47614.5 authorizes the Authority to adopt regulations (Title 4, Division 15, Article 1.5 (commencing with Section 10170.1) of the California Code of Regulations) to implement the Program and declares the adoption of a Program regulation by the Authority as deemed to be an emergency for the purposes of the Administrative Procedure Act (Chapter 3.5 (commencing with Section 11340) of Title 2 of the Government Code).

NOW, THEREFORE, BE IT RESOLVED by the California School Finance Authority as follows:

- **Section 1**. The proposed regulations for the Program regarding attendance area and COVID are hereby approved in substantially the form presented on this date.
- <u>Section 2</u>. The Executive Director is hereby authorized, for and on behalf of the Authority, to submit such regulations, with any and all required supporting documentation, to the Office of Administrative Law and proceed as required under the Administrative Procedures Act through the regular rulemaking process.
- <u>Section 3</u>. The Executive Director is hereby authorized to execute and deliver any documents, as well as, making any changes to the regulations text or regulations file as may be necessary or advisable to effectuate the purposes of this Resolution.
