## APPROVAL OF FINANCIAL SOUNDNESS DETERMINATION FOR SAN DIEGO UNIFIED SCHOOL DISTRICT ON BEHALF OF KAVOD CHARTER FOR PRELIMINARY AND ADVANCE APPORTIONMENT THROUGH THE CHARTER SCHOOL FACILITIES PROGRAM

**WHEREAS**, the Charter School Facilities Program (Program) was established for the purpose of providing charter schools with funding to construct new facilities and rehabilitate existing district facilities; and

**WHEREAS**, modeled after the State's School Facilities Program, the Program funds 50 percent of project costs as a grant from the State, and 50 percent as a loan or lump sum, which the charter school or obligor is responsible for repaying to the Program; and

**WHEREAS**, the California School Finance Authority (Authority) and the State Allocation Board, staffed by the Office of Public School Construction, are designated to jointly administer the Program; and

**WHEREAS**, the Authority is authorized by Education Code section 17078.57 to determine whether applicants to the Program are financially sound for purposes of the Program at the time of Preliminary, Advance, and Final Apportionment; and

**WHEREAS**, the Authority is required by section 10154 of Program regulations to conduct a review of San Diego Unified School District's (SDUSD) financial soundness on behalf of Kavod Charter (KC) for purposes of Preliminary and Advance Apportionment; and

**WHEREAS**, this determination of financial soundness will be provided to the Office of Public School Construction as it recommends to the State Allocation Board approval of a Preliminary Apportionment to SDUSD on behalf of KC in the amount of \$32,705,334 for its New Construction and Rehabilitation project; and

**WHEREAS**, SDUSD will fulfill the project's local matching share obligation by providing a lump sum in the amount of \$16,352,667; and

**WHEREAS**, this determination of financial soundness is contingent upon there being no material legal, financial, or operational changes between the date of this resolution and SDUSD's receipt of apportionment on behalf of KC.

**NOW, THEREFORE, BE IT RESOLVED** by the California School Finance Authority as follows:

**Section 1**. That SDUSD has demonstrated its financial soundness for purposes of Preliminary and Advance Apportionment on behalf of KC.

**Section 2**. The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to notify the State Allocation Board and the Office of Public School Construction, and provide supporting documentation, that SDUSD has demonstrated its financial soundness for purposes of Preliminary and Advance, but not Final Apportionment, on behalf of KC.

<u>Section 3.</u> The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to execute the Program Agreements between the State, SDUSD, and KC.

**Section 4.** This resolution shall take effect immediately upon its approval and be in effect for twelve months from the date of adoption.
