AMENDMENTS TO REGULATIONS FOR THE STATE CHARTER SCHOOL FACILITIES INCENTIVE GRANTS PROGRAM AND AUTHORIZING THE REGULAR RULEMAKING PROCESS

March 19, 2025

WHEREAS, the Charter School Facilities Incentives Grant Program (Program) (CFDA #84.282D) assists high performing charter schools in offsetting on-going costs as well as acquisition, construction, and renovation. The three-year grant provides funding for rent, lease, Proposition 39 pro-rata payments, mortgage, construction costs, or debt service.

WHEREAS, in July 2024 the Authority applied for an additional award under the Program and received a \$30 million grant to provide another three funding rounds; and

WHEREAS, the Program's regulations are revised from time to time to account for additional grant funds, update eligibility, improve Program administration, conform federal and state compliance, and access to funding; and

WHEREAS, at this time, the regulations are proposed to be amended to account for the new grant under the Program, compliance with federal requirements, and to ensure funding may be awarded and distributed properly.

NOW, THEREFORE, BE IT RESOLVED by the California School Finance Authority as follows:

<u>Section 1</u>. The proposed amended regulations for the Program are hereby approved in substantially the form attached hereto as Exhibit A. The Executive Director is hereby authorized, for and on behalf of the Authority, to submit such regulations, with all required supporting documentation, to the Office of Administrative Law and proceed as required under the Administrative Procedures Act.

<u>Section 2.</u> The Executive Director is hereby authorized and directed to take such actions, including making or causing to be made such changes to the regulations as may be required for approval of the regulations by the Office of Administrative Law, and to execute and deliver any and all documents and take any and all steps that the Executive Director may deem necessary or advisable in order to effectuate the purposes of this resolution.

Section 3. This resolution shall take effect immediately upon its approval.
