AMENDMENTS TO REGULATIONS FOR THE CHARTER SCHOOL FACILITY GRANT PROGRAM AND AUTHORIZING THE EMERGENCY RULEMAKING PROCESS

WHEREAS, the California School Finance Authority (Authority) is established in Title 1 (commencing with Section 17170) of the Education Code;

WHEREAS, the Charter School Facility Grant Program (Program) is established in Title 2 (commencing with Section 47614.5) of the Education Code and administered by the Authority to provide annual assistance with facilities rent and lease costs for California charter schools that meet certain eligibility and funding criteria, and

WHEREAS, Education Code Section 47614.5 authorizes the Authority to adopt regulations (Title 4, Division 15, Article 1.5 (commencing with Section 10170.1) of the California Code of Regulations) to implement the Program and declares the adoption of a Program regulation by the Authority as deemed to be an emergency for the purposes of the Administrative Procedure Act (Chapter 3.5 (commencing with Section 11340) of Title 2 of the Government Code).

NOW, THEREFORE, BE IT RESOLVED by the California School Finance Authority as follows:

<u>Section 1</u>. The proposed amended regulations for the Program are hereby approved in substantially the form attached hereto as Exhibit A. The Executive Director is hereby authorized, for and on behalf of the Authority, to submit such regulations, with all required supporting documentation, to the Office of Administrative Law, and proceed as required under the Administrative Procedures Act.

<u>Section 2.</u> The Executive Director is hereby authorized and directed to take such actions, including making or causing to be made such changes to the regulations as may be required for approval of the regulations by the Office of Administrative Law, and to execute and deliver any and all documents and take any and all steps that the Executive Director may deem necessary or advisable in order to effectuate the purposes of this resolution.

Section 3. This resolution shall take effect immediately upon its approval.
