Item #3: Executive Director's Report

<u>Charter School Facility Grant Program (SB740)</u>: The 2025 / 2026 funding round is set to close on September 2, 2025 with staff anticipating a lot of applications. Final tuition awards for eligible schools are also currently being processed for the 2024 / 2025 funding round.

<u>Conduit Bond Program</u>: The Authority recently closed two Extended Fund Facility loans for Yu Ming Charter School and James Jordan Middle School. Staff will be presenting a loan for Ednovate Charter School at the September Board meeting.

<u>Charter School Facilities Program:</u> The application for this program closes in October 2025. 4-6 analysts as well as consultants will be assigned to the program and recently completed a 2-day training course in Los Angeles. The Authority recently received a settlement from the Today's Fresh Start litigation settlement and will be distributing the funds as necessary.

<u>Charter School Revolving Loan Fund</u>: Staff will be presenting two loan applications before ethe board today. There will be a hearing on Friday, August 29, 2025 on SB 631: Charter School Revolving Loan Fund that would give priority to schools impacted by disasters and new schools.
