APPROVAL OF FINANCIAL SOUNDNESS DETERMINATION FOR KING-CHAVEZ ACADEMY OF EXCELLENCE FOR FINAL APPORTIONMENT THROUGH THE CHARTER SCHOOL FACILITIES PROGRAM (ED. CODE, §17078.52 ET SEQ.) LOCATED IN SAN DIEGO COUNTY (ACTION ITEM)

WHEREAS, the Charter School Facilities Program (Program) was established for the purpose of providing charter schools with funding to construct new facilities and rehabilitate existing district facilities; and

WHEREAS, modeled after the State's School Facilities Program, the Program funds 50 percent of project costs as a grant from the State, and 50 percent as a local matching share, which the charter school is responsible for repaying to the Program; and

WHEREAS, the California School Finance Authority (Authority) and the State Allocation Board (Board), staffed by the Office of Public School Construction (OPSC), are designated to jointly administer the Program; and

WHEREAS, the Authority is authorized by Education Code section 17078.57 to determine whether applicants to the Program are Financially Sound for purposes of the Program at the time of Preliminary, Advance, and Final Apportionment; and

WHEREAS, during the 2022 Filing Round, San Diego Unified School District (SDUSD) applied for a Preliminary Apportionment (pledging to satisfy the lump sum payment with general obligation bond proceeds) on behalf of King Chavez Academy of Excellence (KCAE); and

WHEREAS, the Authority is required by section 10154 of Program regulations to conduct a review to determine SDUSD and KCAE Financially Sound as it related to the project for purposes of Final Apportionment; and

WHEREAS, this determination of Financial Soundness will be provided to the OPSC as it recommends to the State Allocation Board (SAB) approval of a Final Apportionment to SDUSD on behalf of KCAE in the amount of \$5,024,471.00 for its New Construction project; and

WHEREAS, SDUSD will fulfill the project's local matching share obligation by providing a lump sum in the amount of \$5,024,471.00; and

WHEREAS, this determination of Financial Soundness is contingent upon there being no material legal, financial, or operational changes between the date of this resolution and SDUSD's receipt of apportionment.

NOW, THEREFORE, BE IT RESOLVED by the California School Finance Authority as follows:

Section 1. KCAE has demonstrated Financial Sound as related to the project for purposes of Final Apportionment, in part based on SDUSD's (applicant) lump sum contribution to meet KCAE's local match requirement.

<u>Section 2</u>. The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to notify the SAB and OPSC and provide supporting documentation, that SDUSD (applicant), on behalf of KCAE, has demonstrated its Financial Soundness for purposes of Final Apportionment.

Section 3. The Executive Director of the Authority, and the Chair or their designee is hereby authorized, for and on behalf of the Authority, to execute the Program Agreements between the State, KCAE, and SDUSD, as applicable.

Section 4. This resolution shall take effect immediately upon its approval and be in effect for twelve months from the date of adoption.
