Subject: Resolution No. 26-01 Approving Final Awards and Authorizing the Disbursement of Funds under the 2025-26 Funding Round of the State Charter School Facilities Incentive Grants Program (ALN #84.282D)

Resolution No. 26-01 grants approval of the conditional awards of grant funds to the top-ranking applications in line for a grant award; allowing the Executive Director (or the Deputy Treasurer) to take the steps necessary to execute the grant agreements, disburse the grant funds, and make awards to alternate applications as applicable - in the event program funds become available. The State Charter School Facilities Incentives Grant Program (Program) applicants, potential awardees, and alternates, are shown in Attachment A and B attached hereto.

Background: On behalf of the State of California, in 2004, the California School Finance Authority (Authority) received a five-year, \$49.25 million grant from the U.S. Department of Education for the Federal Program. In 2009, the Authority was awarded a second five-year grant in the amount of approximately \$48.5 million for the Program. In 2014, the Authority applied for and was awarded a third five-year grant in the amount of \$50 million for the Program. *In 2024, the Authority applied for and was awarded its fourth grant through the Program for a total three-year award of \$30 million.*

The Program is intended to provide financial assistance to California charter schools based on demonstrated need. Based on stakeholder feedback through the regulatory process, the Authority developed a 140-point scale to award points based on the following:

- 1) Low Income: Zero to 60 points based on the number of low-income students served by the school (as measured by the number of students eligible for free or reduced-price meals based on data from the California Department of Education (CDE)).
- 2) Every Student Succeeds Act (ESSA) School Proximity: Zero to 10 points based on the applicant being within a specified driving distance from a school serving the same grades and designated by CDE as either a Comprehensive Support and Improvement (CSI) school or an Additional Targeted Support and Improvement (ATSI) school. Driving distance maximum are adjusted for "City/Urban", "Suburban", or "Town/Rural" based on the federal locale code designation.
- 3) Equity Demographics: Zero to 10 points for a comparison with applicant's Chartering Authority on four categories of equity demographics. Schools will receive 2.5 points for each category, English Learners, Foster Youth, Homeless/Unhoused, and/or Students with Disabilities, if the school has a higher percentage than the Chartering Authority. Schools with the same percentage or less will receive zero points.

- 4) Student Performance: Zero to 20 points shall be awarded based on student academic performance on the Smarter Balanced Assessments in English Language Arts/Literacy and Mathematics, as follows: (1) up to 5 points per subject for student achievement levels in ELA and Mathematics; and (2) up to 5 points per subject for year-over-year student progress in ELA and Mathematics, as measured against the school's prior Smarter Balanced Assessment results.
- 5) School Choice: Up to 20 preference points, subject to the availability of statewide assessment data. Points are awarded based on the school's academic performance in English Language Arts/Literacy and Mathematics relative to its Chartering Authority, as measured by the Smarter Balanced Assessments.
- 6) Disaster: Charter schools directly affected by a disaster that is declared a state of emergency by the Governor, or a federal agency may receive up to 20 additional preference points. Eligibility is based on documented displacement from the school's facilities resulting from the declared disaster or replacing/repairing facilities directly damaged by said disaster.

Staff ranked applications based on the preference point scale noted above. Authority staff relied on CDE-certified data to determine preference points for low income, equity demographics, student performance, and school choice. ESSA criteria were determined using the National Center for Education Statistics locale codes. Disaster criteria were determined using California State Board of Equalization's Disaster List, school location, and a description of the circumstances from the school. Applications for this funding round of the Program were due to the Authority no later than August 15, 2025 and the Authority received 163 applications, with funding requests of over \$210,000,000. A data analysis of applicants can be found in Attachment C.

Recommendation: Staff recommends members of the California School Finance Authority Board adopt Resolution 26-01 approving staff's funding recommendations contained in Attachment B of Resolution 26-01. Approval of Resolution 26-01 also authorizes the Executive Director (or the Deputy Treasurer) to execute the grant agreements and disburse the funds on behalf of the Authority as well as make awards to eligible alternates.
