

RESOLUTION NO. 26-01

**RESOLUTION APPROVING AWARDS AND AUTHORIZING THE
DISBURSEMENT OF FUNDS UNDER STATE CHARTER SCHOOL FACILITIES
INCENTIVE GRANTS PROGRAM (ALN #84.282D)**

January 29, 2026

WHEREAS, on behalf of the State of California, in 2004, 2009, and 2014 the California School Finance Authority (Authority) was awarded a \$49,250,000, \$48,500,000, and \$50,000,000 grant, respectively, through the United States Department of Education program entitled the State Charter School Facilities Incentive Grants Program (ALN #84.282) (Program);

WHEREAS, on behalf of the State of California, in 2024 the Authority applied for and was awarded a fourth grant of Program funds in an amount of \$30,000,000, to be awarded over three years;

WHEREAS, in 2025, the Authority received 163 applications for funding and, pursuant to Program regulations, all applications were vetted for eligibility;

WHEREAS, all eligible applicants have been ranked based on a preference point system set forth in Program regulations;

WHEREAS, the ranking of eligible applicants is set forth in Exhibit A.

NOW, THEREFORE, BE IT RESOLVED that

Section 1. The Authority approves the award of grant funds in the amount of \$9.8 million in the following order: first to the highest ranking applicant set forth in Exhibit A in the corresponding amount set forth in Exhibit A, and then to the next highest ranking applicant set forth in Exhibit A in the corresponding amount set forth in Exhibit A, and continuing in that order until all grant funds have been awarded. The lowest-ranking applicant to receive grant funds may receive only a portion of the amount corresponding to that applicant set forth in Exhibit A. The Authority authorizes the Executive Director of the Authority, the Chair of the Authority Board, or any designee of the Chair (each an "Authorized Person") to take the steps in such Authorized Person's reasonable discretion necessary, convenient, or desirable to execute grant agreements and disburse the grant funds as set forth in this Resolution. Disbursement of grant funds is contingent upon the applicant demonstrating that it continues to meet all Program eligibility and funding requirements set forth in the Program regulations. In the event additional grant funds become available and/or applicants eligible for grant funds as set forth above lose eligibility or become no longer eligible for the amount of grant funds set forth in Exhibit A, the Authority authorizes any Authorized Person to enter into grant agreements and disburse grant funds to additional applicants as set forth in this Resolution.

Section 2. The Authority approves and authorizes the Executive Director or an Authorized Person to decrease subgrantee award amounts between board approval and throughout the Grant period. Such grant amounts may decrease based on information provided during semi-annual certification reviews such as decreases in enrollment or reduction in facility costs.
