Notice is hereby given that the California Tax Credit Allocation Committee (CTCAC) will hold a public hearing on September 11, 2019, as required by Section 42(m)(1)(A) of the Internal Revenue Code of 1986, as amended, with respect to proposed amendments to the Low Income Housing Tax Credit Qualified Allocation Plan (within the meaning of Section 42(m)(1)(B) of the Internal Revenue Code) and to California Code of Regulations, Title 4, Division 17, Chapter 1.

To allow all interested persons a reasonable opportunity to express their views, the Committee encourages the submission of written testimony. The hearing itself will consist of two sequential portions. The first portion will consist of CTCAC staff summarizing the proposed substantive changes and answering clarifying questions regarding those proposed changes. The second portion will be the formal hearing wherein comments on the proposed regulation changes will be taken for the record. **Oral remarks may be limited to no longer than five (5) minutes per person.**

Action on the proposed amendments to the Qualified Allocation Plan and Regulations will be considered by CTCAC at a meeting to be held subsequent to the hearing date.
