To allow all interested persons a reasonable opportunity to express their views, the Committee encourages the submission of written testimony. The hearing itself will consist of two sequential portions. The first portion will consist of CTCAC staff summarizing the proposed changes and answering clarifying questions regarding those proposed changes. The second portion will be the formal hearing wherein comments on the proposed regulation changes will be taken for the record. **Oral remarks may be limited to no more than five (5) minutes per person.**

Action on the proposed amendments to the Qualified Allocation Plan and Regulations will be considered by CTCAC at a meeting to be held subsequent to the hearing date.
