4. Consideration of Resolution XLVII under the Higher Education Facilities Bond Act of June 1990, authorizing the issuance of State of California Higher Education Facilities Bonds or Commercial Paper Notes in the principal amount not to exceed \$550,000.\*
5. Consideration of Resolution XLVIII under the Higher Education Facilities Bond Act of June 1990, authorizing the issuance of State of California Higher Education Facilities Refunding Bonds in the aggregate principal amount outstanding not to exceed \$86,570,500.\*
6. Consideration of Resolution XXVI under the Public Education Facilities Bond Act of 1996, authorizing the issuance of State of California Public Education Facilities Bonds or Commercial Paper Notes in the principal amount not to exceed \$26,015,000.\*
7. Consideration of Resolution XXVII under the Public Education Facilities Bond Act of 1996, authorizing the issuance of State of California Public Education Facilities Refunding Bonds in the aggregate principal amount outstanding not to exceed \$705,456,000.\*

8. Consideration of Resolution XXI under the Kindergarten-University Public Education Facilities Bond Act of 2004, (i) amending the provisions of Resolution XVI authorizing the issuance of State of California Kindergarten-University Public Education Facilities Bonds or Commercial Paper Notes in the principal amount not to exceed \$430,000,000, and (ii) authorizing the issuance of State of California Kindergarten-University Public Education Facilities Bonds or Commercial Paper Notes in the principal amount not to exceed (a) the principal amount unissued under Resolution XVI of \$79,000,000, and (b) an additional principal amount not to exceed \$72,825,000, for a total principal amount not to exceed \$151,825,000.\*

Consideration of Resolution XXII under the Kindergarten-University Public Education Facilities Bond Act of 2004, authorizing the issuance of State of California Kindergarten-University Public Education Facilities Refunding Bonds in the aggregate principal amount outstanding not to exceed \$2,299,167,000.\*
