Consideration of Resolution I under the Safe Drinking Water, Wildfire Prevention, Drought Preparedness, and Clean Air Bond Act of 2024, authorizing the issuance of State of California Safe Drinking Water, Wildfire Prevention, Drought Preparedness, and Clean Air Bonds or Commercial Paper Notes in the principal amount not to exceed \$185,000,000*.
