### **State Treasurer Fiona Ma Urges Congress to Support Cleanup Measures in Tijuana River Valley Watershed following trip to San Diego County**

**SACRAMENTO** – State Treasurer Fiona Ma this week called on federal legislators to support the Environmental Infrastructure Program for San Diego County and Tijuana River Valley Watershed in the final conference report for the Water Resources Development Act of 2024, following a recent trip to the area.

In a letter addressed to the Chairs and Ranking Members of the Senate Environment & Public Works Committee and the House Transportation & Infrastructure Committee, the treasurer highlighted the public health and environmental crisis caused by raw sewage contamination and its impact on residents and the economy.

The letter follows an October 7th visit to Imperial Beach in San Diego County and tour of the impacted area. Upon seeing affect on small businesses and recreation areas, the treasurer vowed to address the issue with federal, state, and local leaders in order “to make sure that our kids, seniors, and residents are as safe as possible here in the State of California.”

If authorized, the Environmental Infrastructure Program would allocate \$200 million in investments that would support stormwater management, water quality protection, and environmental restoration efforts.

*Fiona Ma is California's 34th State Treasurer. She was first elected on November 6, 2018, with more votes (7,825,587) than any other candidate for treasurer in the state's history and reelected on November 8, 2022. She is the first woman of color and the first woman Certified Public Accountant (CPA) elected to the position. The State Treasurer's Office was created in the*

*California Constitution in 1849. It provides financing for schools, roads, housing, recycling and waste management, hospitals, public facilities, and other crucial infrastructure projects that better the lives of residents. California is the world's fifth-largest economy and Treasurer Ma is the state's primary banker. Presently, her office processes more than \$3 trillion in banking transactions. She provides transparency and oversight for the government's investment portfolio and accounts, as well as for the state's surplus funds. Treasurer Ma oversees an investment portfolio that currently averages over \$200 billion—a significant portion of which is beneficially owned by more than 2,200 local governments in California. She serves as agent of sale for all State bonds and is trustee of billions of dollars of state indebtedness.*

**RE: SUPPORT: Environmental Infrastructure (EI) Program for San Diego County and  
Tijuana River Valley Watershed**

Dear Chairmen Carper and Graves, and Ranking Members Capito and Larsen,

As California State Treasurer, I am writing to express my strong support for the inclusion of a new Environmental Infrastructure (EI) program for San Diego County and the Tijuana River Valley Watershed in the final conference report for the Water Resources Development Act of 2024. This initiative is a crucial component in both the Senate bill, S. 4367, and the House bill, H.R. 8812.

The urgency for this funding cannot be overstated: this area of our state grapples with a significant public health and environmental crisis due to raw sewage contamination in the Tijuana River Valley. This situation poses severe risks not only to local residents but also to federal Customs and Border Protection personnel and Navy SEALs who train in these waters.

For years, the San Diego community has endured the detrimental effects of untreated sewage flowing from Mexico into the Tijuana River Valley, resulting in a dangerous mix of pathogens and pollutants. Recent studies have brought to light the serious health risks tied to this pollution, including respiratory problems and exposure to waterborne diseases. The recent storms worsened this situation, contributing an estimated 14.5 billion gallons of raw sewage into local neighborhoods.

The continual discharge of untreated wastewater has also taken a toll on our state's economy. For instance, during Labor Day weekend, unsafe water conditions led to the closure of three beaches in San Diego County, impacting both residents and visitors and harming businesses that depend on beach tourism.

The proposed Environmental Infrastructure program represents a vital investment needed to build the infrastructure required to address pollution in our waters. This funding would support essential projects focused on stormwater management, water quality protection, and environmental restoration. Such initiatives are critical to ensure that our beaches remain safe and inviting for everyone, and prioritize the health and well-being of San Diego County residents.

As your committees prepare for conference negotiations, I strongly urge you to authorize this EI program at the House-passed level of \$200 million. This investment will generate significant benefits for the economy, environment, and public health. I stand in solidarity with San Diego's Congressional delegation in advocating for this essential initiative and appreciate the commitment of our Senators to support this program in the Senate bill.
