INFORMATION ITEM -Creation of New Interest-Bearing Demand Account with U.S. Bank

Mr. Josh Rivera stated that the Treasurer has established a new interest-bearing demand account with U.S. Bank. Mr. Andre Rivera asked for public comments; there were none.

POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Josh Rivera of the State Treasurer's Office presented the Portfolio Summary Report as of April 30, 2023. The total portfolio amount was \$185.361 billion, the effective yield was 2.885%, and the average life was 269 days. The amount of loans approved was \$343 million with a disbursed amount of \$214 million. The total deposit amount for the Local Agency Investment Fund was \$27.029 billion with 2,362 participants.

Mr. Josh Rivera then presented Designation No. 1887.

SURPLUS MONEY DECLARATION AND REDUCTION

Mr. Josh Rivera presented the changes in the Surplus Money Investment Fund for the period April 1, 2023 through April 30, 2023. The Declaration of Surplus Money was in the amount of \$15.680 billion and the Reduction of Surplus Money was in the amount of \$12.844 billion.
