### POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Rivera of the State Treasurer's Office presented the Portfolio Summary Report as of June 30, 2023. The total portfolio amount was \$178.383 billion, the effective yield was 3.257%, and the average life was 260 days. The amount of loans approved was \$359 million with a disbursed amount of \$239 million. The total deposit amount for the Local Agency Investment Fund was \$25.677 billion with 2,361 participants.

Mr. Rivera then presented Designation No. 1889.

Treasurer Ma asked for public comments; there were none. Mr. Oppenheim moved to approve Designation No. 1889. Upon a second by Ms. Li, the motion passed 3-0 with the following votes: Treasurer Ma: yes; Mr. Oppenheim: yes; Ms. Li: yes.

#### SURPLUS MONEY DECLARATION AND REDUCTION

Mr. Rivera presented the changes in the Surplus Money Investment Fund for the period June 1, 2023 through June 30, 2023. The Declaration of Surplus Money was in the amount of \$14.795 billion and the Reduction of Surplus Money was in the amount of \$19.095 billion.
