Mr. Shower of the State Treasurer's Office presented the Portfolio Summary Report as of October 31, 2023. The total portfolio amount was \$165.733 billion, the effective yield was 3.831%, and the average life was 250 days. The amount of loans approved was \$381 million with a disbursed amount of \$266 million. The total deposit amount for the Local Agency Investment Fund was \$21.65 billion with 2,351 participants.
