POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Shower of the State Treasurer's Office presented the Portfolio Summary Report as of April 30, 2025. The total portfolio amount was \$172.758 billion, the effective yield was 4.270%, and the average life was 238 days. The amount of loans approved was \$240 million with a disbursed amount of \$122 million. The total deposit amount for the Local Agency Investment Fund was \$23.878 billion with 2,334 participants.

Mr. Shower then presented Designation No. 1911.

Treasurer Ma asked for public comments; there were none. Ms. Evans moved to approve Designation No. 1911. Upon a second by Ms. Perrault, the motion passed 3-0 with the following votes: Treasurer Ma: yes; Ms. Evans: yes; Ms. Perrault: yes.

SURPLUS MONEY DECLARATION AND REDUCTION

Mr. Shower presented the changes in the Surplus Money Investment Fund for the period April 1, 2025, through April 30, 2025. The Declaration of Surplus Money was in the amount of \$17.181 billion and the Reduction of Surplus Money was in the amount of \$15.317 billion.

Mr. Shower stated there were no SMIF requests this month.

INFORMATION ITEM - Pooled Money Investment Account Investment Policy Review

Mr. Shower stated that the PMIA Investment Policy is presented to the PMIB at least annually as an information item. The policy has been updated to refine and consolidate language, remove redundancies, and clearly define minimum credit rating requirements for each investment category.

Treasurer Ma asked for public comments; there were none. Ms. Evans added that on behalf of the Controller, she commends the amazing work done by the Treasurer and her team. Treasurer Ma thanked Ms. Evans.

LOAN REQUESTS

Mr. Kevin Esmeralda, of the State Treasurer's Office Public Finance Division, presented the loan requests. Staff recommended approval of two new loan requests (Agenda Item 7). Mr. Esmeralda reported the loan requests are in compliance with the current Pooled Money Investment Account Loan Policy and upon approval would result in a decrease to the outstanding loan balance by \$4,208,000.00.
