#### CalSavers is coming! Here's what you need to know:



The state is launching a new retirement program that will enable employers to provide their employees with access to a payroll deduction Individual Retirement Account (IRA) at no cost to the employer or taxpayer. CalSavers is a voluntary workplace IRA program for private sector workers designed to be simple and portable from job to job. CalSavers will be professionally managed by a private sector financial firm with oversight from a transparent public Board.

When CalSavers launches statewide on July 1, 2019, state law will require all businesses with five or more employees to either offer a retirement savings vehicle from the existing market or register for CalSavers. Deadlines for employers to comply will roll out over a three year period based on the size of business.

CalSavers is a great way for employers to facilitate their employees' access to a portable retirement program. There are zero fees for employers. Since CalSavers is not an employer sponsored plan, employers will have no fiduciary liability, and it will be administratively easy for employers to facilitate. Prior to joining the CalSavers team, he spent 3 years at the State Treasurer's Office helping California's local agencies invest their idle funds in the Local Agency Investment Fund (LAIF), and 13 years at Citibank where he assisted with the organization's business development and outreach strategies, and worked with a team of advisors to provide wealth management services and solutions for individuals, families, and businesses. Jonathan has a BA in Government from California State University, Sacramento.

## Franchise Tax Board (FTB)

Lillian Conroe is the Small Business and Permit Specialist for the California Governor's Office of Business and Economic Development (GO-Biz) which provides assistance to new and existing small businesses in southern California. Lillian was appointed by Governor Brown in September 2012.

Prior to her appointment, Lillian worked for Cal Recycle as the supervisor of the Waste Tire Enforcement and Permitting of the landfill/lea units.

Her responsibilities included inspection of used tire shops and un-permitted tire haulers, permitting of landfills and transfer stations in southern California.

Previously, Lillian was the director of the Business Revitalization Center (BRC), a one stop permit assistance center in Los Angeles which provided permit assistance to businesses rebuilding after the 1994 earthquake.

Lillian also worked in collaboration with the city and county agencies building of the Staple Center and Kodak Theater.

Lillian's career started with the Employment Development Department (EDD) as a job service representative working with ex-felons and long term unemployed to find employment. 13



#### **CALIFORNIA POLLUTION CONTROL FINANCING AUTHORITY (CPCFA)** California Capital Access Program (CalCAP)



The California Pollution Control Financing Authority (CPCFA) has been providing low-cost innovative financing to California businesses since 1972 with an objective of making California more economically prosperous and environmentally clean. As a government agency that issues tax-exempt private activity bonds, CPCFA can facilitate low cost financing to qualified waste and recycling projects, and other projects to control pollution and improve water supply.

CPCFA also administers the California Capital Access Program (CalCAP), which encourages financial institutions to make loans to small businesses and provides for specialty programs targeted toward creating more charging stations for electric vehicles, helping at-risk small businesses comply with requirement of the federal Americans with Disabilities Act, assisting small businesses and property owners with financing the costs to seismically retrofit existing buildings and homes, and replacing polluting diesel trucks.

In addition CPCFA also assists with the clean-up of contaminated sites through a grant and loan program and a site-assessment loan program known as California Recycle Underutilized Sites Program (CALReUSE).

Ms. Webster-Hawkins has served as an environmental and land use attorney and general counsel in both the public and private sectors, and as an administrator at several state agencies. In those roles, she has been at the drawing table of many successful public-private

partnerships to advance California's environmental and economic policy goals, including collaborations between state agencies, local agencies, business and non-governmental organizations. Ms. Webster-Hawkins graduated from Stanford Law School where she was selected as a Public Interest Law Fellow.
